At a regular session of the County Commission in and for the aforesaid County and State, at the Wees Annex, on the 17th day of October, 2024 at 1:30 p.m.

Present: Randolph County Commissioners David Kesling and Chris See. Randolph County Commission President, Chris Siler was absent.

Meeting called to order by Commissioner Kesling

PUBLIC COMMENT: None

#### MINUTES:

Commissioner See moved to approve the minutes from the regular meeting that was held on October 3, 2024, as submitted. All yes – Motion passed unanimously

#### REPORTS:

North Central Community Corrections Director, Erin Golden reported that there are currently 121 participants on the Community Corrections program and the program has saved the County \$570,950.40 in regional jail bills, so far this fiscal year.

County Clerk Brenda Wiseman gave an Election report. She said the public test of the voting equipment/machines will be held tomorrow at 10:00 a.m. in the Courthouse Lobby and everyone is invited to attend. She said early voting will begin on Wednesday October 23 and run thru Saturday November 2<sup>nd</sup>. It will be held at the Wees Annex and at the Russell Memorial Public Library in Mill Creek. The hours of early voting are Monday thru Friday 8:00 a.m. to 4:30 p.m. and Saturdays from 9:00 a.m. to 5:00 p.m. She reminded everyone that Saturday November 2<sup>nd</sup> at 5:00 is the cutoff for early voting. She said if you have not early voted by then you will have to wait until Election Day on November 5<sup>th</sup> to go to your precinct to vote. On election day the polls will be open from 6:30 a.m until 7:30 p.m.

CORRESPONDENCE: None

#### ANNOUNCEMENTS:

Commissioner Kesling announced that the next meeting of the Randolph County Commission will be held on November 7, 2024 at 1:30 p.m. in the Wees Annex. He said there was a special meeting scheduled for today at 1:00 p.m. but that has been changed to Tuesday October 22<sup>nd</sup> at 3:00 here. The special meeting is regarding the pre-construction of the new courtroom.

Commissioner Kesling also announced that Lady Justice has been taken off the main Courthouse building by High Point Construction and she will be taken to Morgantown to get restored due to ice damage and wind damage. He said they put in an insurance claim and will be receiving part of the funding to restore her from that, but the County will still be responsible for some of it. He said they are hoping to have her back by next spring.

#### ITEMS FOR DISCUSSION/ACTION:

#### INFORMATIONAL PRESENTATION ON RANDOLPH COUNTY POOL AND SPLASH PAD

Stanley Teets and Amber Walsh appeared before the Commission on behalf of the Elks. Amber said for the 2024 season they had over 9,000 guests at the pool/splash pad. She said that averages to about 113 per day. She said they had buses from local schools come, kids from the 4-H camp, kids from the Children's home and the YMCA summer camp kids came. She said they held 67 private parties and the lifeguards gave swim lessons. She said they had 3 parties that were donated by local organizations and 2 free swimming days sponsored by businesses. She said they had \$23,000.00 in concession sales and used 20 employees. She said in December they will start selling passes for next season at a discount. She said the pool has been winterized and they will do maintenance in the spring. Stanley said they

have expenses at the Pool such as chemicals, maintenance and payroll. He said they had a very good crew and had a great year. He said the new slide was great. He thanked the County Commission for all their help and without them they couldn't do it. Commissioner Kesling said it was a better year than last year and he appreciates everything they do. He said he is aware of the maintenance coming up. Commissioner See said people are very happy with it.

INFORMATIONAL PRESENTATION FROM FRONTIER AND CONSIDER APPROVAL OF BEAD LETTER OF SUPPORT (See copy attached)

Commissioner Kesling said they did a letter of support at the last meeting for CityNet and this time it's Frontier asking for the same letter of support. He said they are trying to bring fiber broadband service through Randolph County. He said with this letter of support Frontier can apply for funding from the Broadband, Equity, Access and Deployment (BEAD) grant. Commissioner Kesling moved to approve a letter of support for Frontier to apply for the BEAD grant, as presented. All yes – Motion passed unanimously

#### INFORMATIONAL PRESENTATION FROM THE CELTIC FESTIVAL

Timothy Ferguson, President of the Celtic Festival and Highland Games appeared before the Commission. He thanked the Commission for their past support. He said they held the festival on June 20-22 this year. He said they had approximately 2,700 people attend. He said people came from all around such as Florida and Montana. He said all the hotels were booked and the RV Sites at Camp Pioneer were full. He said the vendors were happy and want to come back. He said the Humane Society was there and sold T-Shirts to raise funds. He said everyone should check out their website and facebook page for more information. He said they are starting to plan and organize for next year's festival. He said they haven't been able to secure the 4-H Camp Pioneer yet but they definitely still want to have it there. He said they will be having a few fund raisers coming up soon such as bar crawl. He said they would like for one of their committee members to be able to join the Parks and Recreation Board, if possible. Commissioners Kesling and See said they would have to check with 4-H Board to see if they have any openings.

#### CONSIDER APPROVAL OF DOMESTIC VIOLENCE PROCLAMATION (See attached copy)

Emmaline Metheny appeared before the Commission on behalf of Centers Against Violence. Megan Phares was also in attendance. Ms. Metheny said October is a very important month to spread awareness about domestic violence. She said not only for Women but Men also. Commissioner Kesling moved to approve the Proclamation declaring October as Domestic Violence Awareness Month in Randolph County. All yes – Motion passed unanimously

#### CONSIDER APPROVAL FOR NEW HIRE IN TAX OFFICE (See copy attached)

Sheriff Elbon said they had an opening in his office and he has chosen Sherry Ann Gibson for the position of Tax Deputy. He said a background investigation was completed which she successfully passed. He would like her to begin working on October 29, 2024 with a 90 day probation and with a starting salary of \$25,000.00 per year with full benefits. Commissioner See moved to hire Sherry Ann Gibson as a full time benefited Tax Deputy with a starting date of October 29, 2024 and with a starting salary of \$25,000.00 per year and she will be placed on a 90 day probation period. Dear Ms. Workman:

The County of Randolph has determined that ubiquitous availability of affordable fiber broadband services for residents and businesses is essential and would enhance the quality of life for our residents and position the County for continued economic growth. Frontier West Virginia Inc. ("Frontier") has been working cooperatively with Randolph County and its stakeholders in the pursuit of Broadband, Equity, Access and Deployment ("BEAD") funding to bring world-class fiber broadband service to unserved and underserved locations that are desperately in need of fast, reliable broadband service, at affordable rates.

Randolph County is committed to working cooperatively with Frontier to bring fiber broadband service, with residential speeds of at least 5/5 Gbps and small business speeds of at least 2/2 Gbps to unserved and underserved locations in the County. It is the intent of Randolph County and Frontier that the proposed project will support the broadband connectivity needs of our residents and businesses well into the future.

Frontier's expansion of fiber broadband in our county will support Randolph County's economic development and growth initiatives which include connecting every resident and business with access to high-speed internet to help transform the way our residents interact with technology,

education, and business opportunities with a goal of elevating the standard of living and economic prospects for the entire County.

Frontier has discussed with the County its intent to pursue BEAD funding to reach unserved and underserved locations, locations that are high-cost and cannot be economically justified without grant funding. Randolph County has committed its support of Frontier's grant application(s) and welcomes the benefits that will result from Frontier's deployment of fiber in the community.

Randolph County and Frontier agree to work cooperatively in this effort to: 1) gather the necessary localized documentation and support (including letters of support from community members) for Frontier's BEAD grant proposal; 2) in simplifying and expediting the permitting process to minimize disruption to right-of-way, reduce project cost and expedite project completion, as feasible; and 3) to communicate service availability and low-income/affordable service options to the community, with an emphasis on targeting disadvantaged households and closing the digital divide.

The Randolph County Commission hereby endorses Frontier's proposed BEAD applications. Frontier has worked with the County to seek input on the project which would bring world-class fiber broadband to our residents and businesses. The project will provide new educational, employment and health care benefits to our residents that lack reliable, affordable high-speed broadband service. Further, Frontier's service rates are highly competitive, including a 200/200 Mbps service priced at \$29.99 per month with enrollment in autopay that is available to all consumers regardless of income, and Frontier participates in the federal Lifeline program, which provides a service credit to low-income consumers. As a result, Frontier has taken steps to make its services not only available but also affordable.

On behalf of the County of Randolph, the County Commission endorses Frontier's BEAD applications and the benefits Frontier's fiber will bring to the economic viability of Randolph County and the overall quality of life it will bring to our residents as well as local businesses.
