Meeting called to order by Commissioner Kesling

PUBLIC COMMENT: None

MINUTES:

Commissioner See moved to approve the minutes from the regular meeting that was held on January 2, 2025, as submitted. All yes – Motion passed unanimously

#### **REPORTS:**

Sheriff Elbon gave a year end report for his Law Enforcement Office. He said this is something Chief Deputy Brad Sharp prepares every year. He said they had 6,973 calls for service. There were 578 offenses, 171 people arrested, 377 car wrecks, 1,698 traffic stops with 768 warnings and 509 citations issued. He said they also served paperwork and completed 49 transports. He reported on the activity of Nicky and Twix, the two K-9 Officers. Commissioner Siler asked how many Deputies does Sheriff Elbon have at this time and he said 18. He said Deputy Waldron is on military leave for one year.

911/OEM Director, Mike Miller reported that Motorolla was at the 911 Center the day before and did an update on the Siron network. He said they had to go up to the Rich Mountain tower and borrowed a snow cat to get up there. He said the snow cat lost power and they spent most of the night trying to get it back out. He said there is a lot of equipment at the 911/OEM Office that is going out of date. He said that is something they will need to keep an eye on. Commissioner Kesling asked about the television station removing local news channels. He asked if Mr. Miller knew if there can only be one station in the County. Mr. Miller said he doesn't know. Commissioner Kesling said the public has been reaching out to the Commissioners about this. Robbie Morris was present and said it's a contract dispute with Nexstar Media Group. Commissioner See said they reached out to some other companies years ago such as Time Warner and they didn't want to come in here.

Rhett Dusenbury was present. He said he was hired by Congressman Riley Moore and he is going next week to DC for training. He said he is happy to be able to stay working with the County Commission.

North Central Community Corrections Director, Erin Golden appeared before the Commission. She said there are currently 105 participants on the program and the program has saved \$1,009,514.40 in regional jail bills so far this fiscal year.

ITEMS FOR DISCUSSION/ACTION:

CONSIDER RATIFICATION OF SIGNATURE ON FY26 BUDGET REQUEST FROM THE CITY OF ELKINS (See copy attached)

Commissioner Kesling said the Commission received a letter from Elkins City Clerk, Sutton Stokes regarding the funding of the Humane Officer. They are going to be working on their budget soon and need that information. Commissioner Kesling said the City of Elkins usually gives the County

Commission \$7,000.00 per year in funding for the Humane Officer. He said this year they are asking for \$10,000.00 because of the increasing demand for service within the Elkins city limits. Commissioner Kesling said the Humane Officer is going to prepare a report for them. Commissioner Siler moved to approve the ratification of signature on the FY26 budget request letter for the City of Elkins, as presented. All yes – Motion passed unanimously

## CONSIDER APPROVAL OF MICROLOGIC'S MBPS PROJECT RESOLUTION

A representative from Micrologic appeared before the Commission. He provided the Commission with a map of the fiber project in Randolph County. He said they are headquartered in Buckhannon but purchased property on Harrison Avenue to set up an office so people can walk in and pay their bill, etc. He said they have the largest WISP service with 100 towers over 9 counties. He said they are working on 2 projects in Randolph County. He said one is in the rural area in Job, Whitmer and Gandy and they have 13 miles to do. He said there are currently 4,900 unserved locations they are working on. He said within the next few months they will be turning up the service in Norton, Coalton and Elkins areas. He said they have to co-locate on Mon Power poles and there is a permit process to do that which has changed over the last 2 years and is getting more expensive. Senator Robbie Morris was also present for this discussion. Commissioner Kesling said the County Commission received a check for \$957,000.00, in which the County is a pass thru agency, for the Micrologic project. Commissioner Siler moved to approve Micrologic's MBPS project resolution in the amount of \$957,000.00. All yes – Motion passed unanimously

## CONSIDER APPROVAL OF STATE OF EMERGENCY POLICY FOR HANDBOOK

Commissioner Kesling said with the recent bad weather the Courthouse had to be closed for a couple of days. He said there is nothing in the policy handbook about this situation. He said he talked to an HR representative and they came up with something for the handbook. Commissioner Kesling read over what they came up with. Discussion followed. Commissioner Siler said for the Deputies and 911 Center they should go by what the Civil Service Board does. He said if the person had to work, they would get time and a half or if they didn't have to work, they would get time and a half or they could take another calendar day off. Commissioner Siler said he thinks the Commission should do the calendar day off policy. Commissioner Kesling said the HR representative did not find that in the Code anywhere. He said he would like to talk to him some more about this before a decision is made. Commissioner Siler moved to table this item until further clarification. All yes — Motion passed unanimously

# CONSIDER APPROVAL OF NEW HIRES FOR COMMUNITY CORRECTIONS (See copies attached)

North Central Community Corrections Director, Erin Golden appeared before the Commission. She said Zachary Judy left his position in her office back in November. She said they conducted interviews for the position. She said at the last board meeting the board approved for her to hire 2 people because they feel with a another Judge now they are going to be busier. She said the first person she would like to hire is Brock Schoonover. This would be for a full time DRC Officer position with full benefits with a starting wage of \$14.42 per hour and he will be placed on a 90 day probationary period. She said this position is already budgeted for in the 072 fund. Commissioner Siler moved to approve the hiring of Brock Schoonover, as submitted. All yes – Motion passed unanimously

Erin Golden said the next person she would like to hire is Linlee Haddix. This would be for a full time DRC Officer position with full benefits with a starting wage of \$14.42 per hour and she will be placed on a 90 day probationary period. She said this position's salary and benefits will come out of the 072 funds. Commissioner Siler moved to approve the hiring of Linlee Haddix, as submitted. All yes – Motion

# CONSIDER PAYMENT DISBURSEMENT OF 3<sup>RD</sup> PAYMENT TO VERITAS FOR THE COURTROOM CONSTRUCTION

Commissioner Kesling said this is for a payment to Veritas Contracting, LLC which is the contractor that is working on the new Judge's courtroom renovations in the Cain Annex. He said the original contract was for \$218,785.00. He said this is the third payment the County has paid and this payment is in the amount of \$22,574.85. He said that leaves a balance of \$151,064.25 remaining to be paid. He said he

meets with them weekly and will be doing a walk thru tomorrow. He said they are waiting for the Supreme Court IT to come and run the data lines to the bench. He said they also found out that the height of the walls are too high. They were built at 41 ½ inches and they were supposed to be 36 inches. He said he isn't sure whose fault that was but he will find out. He said there are also some other change orders that will have to be done and the furniture still has to be purchased. He said all together it will be around \$300,000.00. Commissioner See moved to approve the payment disbursement to Veritas Contracting, LLC in the amount of \$22,574.85.
