- Shelby Wilson discussed a funding request for a female sober living home through Ally's Hope Inc. This request was for \$250,000 to purchase a home that would be a state certified faith-based sober living home. Zach and Debbie spoke about the importance of this facility. Shelby's goal would be to support both the addict and their family through this program. She plans to find a live-in house manager/peer support specialist. The home would comfortably hold 10 women and would be part of the 12-step program. The home would become self sufficient off of the rent collected from each lady that stays. They would have to sign and contract and be subject to rules and drug tests. A failed drug test would send them back to rehab.
- Cris Siler made a motion to approve the funding request in the amount of up to \$250,000 to purchase and start this home.
- Rob Elbon seconded the motion.
- Motion approved.
- Rob Elbon discussed a funding request for a month and a half of the Jail Bills. Parker spoke about why this important and the increase in Jail Bill fees recently.
- Rob Elbon made a motion to approve the funding request in the amount of \$165,000.
- Cris Siler seconded it.
- Motion approved.
