PUBLIC COMMENT: None

MINUTES:

Commissioner See moved to approve the minutes from the regular meeting that was held on October 1, 2025, as submitted. All yes – Motion passed unanimously

REPORTS:

Sheriff Rob Elbon reported that he had been out on a search for a Berkeley County man that had been reported missing. He said his truck was found abandoned a few days ago and his body was located about an hour ago.

Kenneth Watson, Randolph County Court Security gave a report for September, 2025. He said they scanned 2,834 people confiscated 285 knives and 13 pepper sprays. He said they had 59 inmates into custody and process served 156 people. He said the guys are doing a wonderful job. He said there was a high profile case in Magistrate Court this week and the guys did great.

Commissioner Kesling gave a report from the Randolph County Humane Officer. This report covers September 3rd to October 16th. The Humane Officer had 108 calls with 61 being in the County and 47 in the City of Elkins.

RE: Intent to Revert Deputy Roger Foster to Full-Time Employment

Deputy Roger Foster has requested to be transferred to full-time employment as a Deputy Sheriff due to the existing vacancies within our Office. Deputy Foster has served honorably with our Office since 2012. In 2014 he transitioned to part-time status, and has continued serving in that capacity since. Our Office spoke with legal counsel regarding the request. We were informed that since there was no break in service with Deputy Foster transitioning to part-time, he still maintained civil service seniority for the equivalent of the full-time calculation he worked and just needed re-classified as a full-time Deputy Sheriff. As such it is my intent to reclassify him as a full-time benefitted Deputy Sheriff effective October 27, 2025. His beginning full-time rate of pay will be \$26.44 per hour.
