CONSIDER APPROVAL OF FUNDING REQUEST FROM OUR TOWN FOR 4<sup>TH</sup> OF JULY FIREWORKS

Priscilla Gay appeared before the Commission. She said this is the first time that Our Town will be doing the fireworks presentation. She said they have been working with Elkins Fire Chief Steve Himes and their fireworks shooter Andy Burns to try to make it a better show. She said in talking to them they have found out that shooting from a hill is not a good location and flatland is much better. She said they are trying to get an area of the railyard property and are still working on that. She said they want to shoot off the fireworks on flat land and after a really good concert. She said they also found out from Mr. Himes and Mr. Burns that to have a good show \$10,000.00 is the minimum amount to spend. She said Elkins has never gotten close to spending that amount. She said they have a national business with a presence in the Elkins area that has agreed to give them 1/3 of what they are asking for. She said they are asking for \$7,500.00 from the Commission. She said they need to pay for the fireworks by December to get a discount price. Commissioner Kesling said he wants to make sure the car show gets funded too. Commissioner Siler moved to approve the funding request from Our Town in the amount of \$7,500.00 and that is to be taken out of Hotel/Motel Tax funds. All yes – Motion passed unanimously
