REPORTS:

911/OEM Director Cindy Hart reported that she has been working on the traffic problems in Beverly that was discussed at the last meeting. She said she spoke to the Department of Highways about getting signage to stop the big trucks from going onto the back roads and they said they could do it but it would be with low priority and it could be done by the end of this year or possibly into next year sometime. She said the next piece was regarding a letter that the Department of Highways had sent to the Mayor of Beverly back in 2005 regarding moving a house and widening the roads in the sharp turn and that was a grant that has since been exhausted and she spoke with Mr. Rossi at the Department of Highways and he said he has no intentions of spending any money towards that project. She said she did write a grant with the Atlantic Coast Pipeline and they have many grants, but when she checked on the application she was told that the Department of Highways was working with the Atlantic Coast Pipeline and she explained to them that this was a little bit different than the regular signs and they didn't want the large trucks going up the side roads and since that is different they have taken it back to be reviewed and they are going to get back with her by the end of next week and let her know if they qualify for that grant. She has contacted the developers with GPS and she is waiting on their email to be able to upload our system and our mapping into the Garmin's and what not. She said what she understands is once she puts the information into one it goes into all of them. Commissioner Taylor said he is a little concerned with the lack of concern from the DOH about getting signs put up at Files Creek Road. He said they cannot wait a year to do that. He is going to recommend to put it on the next meeting's agenda to draft a letter from the Commission to the Secretary of Transportation.

ITEMS FOR DISCUSSION/ACTION:

CONSIDER REQUEST FOR INCREASED FUNDING IN THE NEXT FISCAL YEAR BUDGET FOR ALL LIBRARIES IN RANDOLPH COUNTY

Nicole Matthews, Director of the Valley Head Library appeared before the Commission. There were several other representatives from other libraries present also. Mrs. Matthews said she was there to request an increase in funding for the 2019 budget. She said libraries are not just for books anymore. She said people come to use the computers, have social activities and use the meeting rooms. She said they can do fundraisers all they want but if they don't have grant match funding they cannot get grants. She said in order to keep getting the grant funding they would like to have an additional \$30,000.00 per year. Commissioner Taylor asked how much additional funding do they need this year for all the libraries to get the grant match? Mrs. Matthews said \$4,000.00 per library and there are five libraries. Commissioner Taylor said they will be meeting in early March to do the budget and they would make the decision then and let them know.

CONSIDER REQUEST FROM BEVERLY VFD FOR A LIMITED BEER PERMIT FOR TWO UPCOMING EVENTS

Commissioner Taylor said the Commission received a request from the Beverly Volunteer Fire Department for a letter from the Commission that they do not object to them getting a limited beer permit for two upcoming events.

Commissioner Scott moved to approve the request of a letter of no objection for a beer permit for the elimination dinner on February 10, 2018.

All yes - Motion passed unanimously

Commissioner Scott moved to approve the request of a letter of no objection for a beer permit for the gun bash on September 7, 2018.

All yes - Motion passed unanimously

CONSIDER FUNDING REQUEST FROM HOOKED ON FISHING (See attached letter)

Robin Miller, Hooked on Fishing Not on Drugs Committee Chairman, appeared before the Commission. Also present with her was Jeff Skidmore. She said this will be the 24th year of Hooked on Fishing Not on Drugs and it will be held on March 17, 2018 at Elkins High School. She said last year the County Commission gave \$5,000.00 and it was a great help. She said one of the other sponsors decreased their funding this year by

\$2,000.00. It costs approximately \$20,000.00 to have it. The purpose of HOFNOD is to promote an anti-drug and alcohol message by promoting outdoor experiences as a positive alternative. Commissioner Taylor said he appreciates them coming today but after researching it the Commission discovered that HOFNOD was already in the budget to receive \$5,000.00 for this year.

CONSIDER APPROVAL/SIGNAGE TO MAINTENANCE AGREEMENT WITH UNIVERSAL ENGINEERING AND CONTRACTING TO MONITOR VARIOUS GENERATORS IN THE COUNTY

Commissioner Taylor said after super storm Sandy the County Commission purchased generators for all the fire departments so they could be used as shelters/warming stations. This is the maintenance agreement to keep them going. It covers the batteries, fuel and usage rates. This is a local company run by Pat Smith. Cindy Hart said this is for maintenance only and it doesn't cover the costs to repair them if they break down. Cindy Hart said the last time we opened warming stations people said that it wasn't advertised enough. She said the fire stations are run by volunteers so they can't send people there if no one is there to open them up. Commissioner Scott moved to approve the signing of the maintenance contract with Universal Engineering and Contracting, as submitted. All yes – Motion passed unanimously

CONSIDER APPROVAL/SIGNAGE OF NEW MAINTENANCE AGREEMENT WITH SOFTWARE SYSTEMS

Commissioner Taylor said the Commission received a letter from Software Systems regarding an upgrade to the system changing it from version 7.1 to 7.2. If we don't do the upgrade there could be a penalty. This is for the AS400 that is used by the Sheriff's Office, County Clerk's Office and Circuit Clerk's Office. This upgrade will cost \$1,689.70. Commissioner See moved to approve the upgrade with Software Systems for the AS400 in the amount of \$1,689.70.

All yes - Motion passed unanimously

CONSIDER APPROVAL OF INTERN TO THE PROSECUTING ATTORNEY'S OFFICE

Randolph County Prosecuting Attorney, Michael Parker appeared before the Commission. He said he was contacted by the Randolph Technical Center about getting an intern for his office which is a high school senior. He said the person he would like to have as an intern is Caiflin Weese. This would be until the end of the school year and it would be with no pay and no benefits.

Commissioner Scott moved to approve the internship of Caitlin Weese in the prosecuting attorney's office, as requested.

All yes - Motion passed unanimously

CONSIDER APPROVAL OF NEW HIRE OF DISPATCHER TO 911 CENTER (See letter attached)

911/OEM Director, Cindy Hart appeared before the Commission. She said she would like to hire Robert Petrice for part time employment to fill a vacant position. His criminal background check had no entries and his references were all positive. The

current budget will cover the cost of training and wages. His starting pay will be \$9.94 per hour and she would like him to begin working on February 2, 2018, if approved. Commissioner See moved to approve the hiring of Robert Petrice as a part time dispatcher at the 911 Center with a starting pay of \$9.94 per hour with no benefits and with an effective date of hire of February 2, 2018. All yes—Motion passed unanimously

OPEN BIDS FOR AERIAL PHOTOGRAPHY

Commissioner Taylor said the Commission advertised for bids for this project for the Assessor and 911/OEM Office. They received two sealed bids. He said their Administrative Assistant, Donna Haddix received one by email but since it was not a sealed bid it was not accepted. The Commission opened the two sealed bids.

- 1. Tuck Mapping Solutions, Inc. from Big Stone Gap, Virginia \$49,500.00
- 2. Blue Mountain Aerial Mapping and Engineering from Burton, WV \$34,665.00

Commissioner Taylor said the Commission and everyone involved will review these bids and make a decision at a later date. Assessor Phyllis Yokum said she was disappointed that there were not more bids because they advertised it in several places.

CONSIDER/APPROVE EMERGENCY ABSENTEE VOTING POLICY (See attached copy)

County Clerk, Brenda Wiseman presented the emergency absentee voting policy to the Commission. She explained that every election cycle this policy needs to be approved by the Commission and sent to the Secretary of State's Office. This allows voters that are in a hospital or nursing home, that didn't vote absentee or early, to be able to vote on Election Day. The two ballot commissioners would take the ballot to them to vote. Commissioner Taylor read the policy out loud. Commissioner Scott moved to approve the emergency absentee voting policy, as submitted. All yes—Motion passed unanimously

MEET WITH PROSECUTOR TO RECEIVE HIS REVIEW OF COUNTY'S CVB'S PRESENTATION FOR FUNDING

Commissioner Taylor said at the last meeting there were three entities that came before the Commission and made a presentation with their request to be considered for the 50% of the hotel motel tax funding. The Commission asked the Prosecuting Attorney to conduct a review and he has prepared a review and will make that presentation to the Commission now. Commissioner Scott moved to go into executive session pursuant to Article 6-9A-4 sub paragraph 7 of the WV Code.

The Randolph County Convention and Visitor's Bureau and the Elkins Depot Welcome Center meet the minimum qualifications as a CVB and Visitor's Bureau and will entertain a motion that this is the findings of this Commission and the second motion will be how the funding is to be distributed.

Commissioner Scott moved that the Randolph County Convention and Visitor's Bureau and the Elkins Depot Welcome Center meet the minimum qualifications as a convention and visitor's bureau therefore entitled to 50% of the county hotel tax money.



EMERGENCY ABSENTEE VOTING POLICY

WHEREAS, West Virginia Code 3-3-5c authorizes county commissions in West Virginia to adopt a policy extending emergency absentee voting procedures in their county; and

WHEREAS, it is the opinion of this Commission that the adoption of such a policy would benefit the citizens of Randolph County:

THE FOLLOWING POLICY IS HEREBY ADOPTED BY THIS COMMISSION:

A person qualified to vote an absent voter's ballot, as defined by West Virginia Code 3-3-1 who is:

- (1) In a hospital or other duly licensed health care facility within a county adjacent to Randolph County or within thirty-five miles of the county seat of Randolph County, for medical treatment; or
- (2) In a nursing home within the county

and is unable to vote in person on election day, may vote an emergency absent voter's ballot under the procedures set forth in West Virginia Code 3-3-5c.
