She said she has not heard back from Charleston yet regarding the grant for the next fiscal year so she doesn't know how much they will be getting.

Sheriff Brady reported that the two new deputies are at the police academy now and he hasn't heard anything yet, so no news is good news.

Commissioner Taylor announced that the Courthouse will be closed on June 20, 2017 for West Virginia day. He also announced that there will be a special meeting held on June 27, 2017 at 10:00 a.m. to pay the end of the year bills only.

#### ITEMS FOR DISCUSSION/ACTION:

CONSIDER REQUEST FROM RANDOLPH COUNTY RECREATION BOARD FOR FUNDING ASSISTANCE WITH UPGRADES TO RESTROOMS AND SEWER SYSTEM AT CAMP PIONEER

Tracy Walker and Phil Tomblyn appeared before the Commission. Ms. Walker showed a power point presentation and told the Commission about everything that is going on at Camp Pioneer. She said in the last five years they have done almost 1 million dollars in capital improvements at Camp Pioneer. She said there are 12 public events scheduled for this summer. She said this brings in a lot of people to the area and has an economic

impact for the County. With more public events and more people coming in they need more bathrooms. The \$25,000.00 that the County Commission gave last year is being used for the sewage project. She said they also have some private donors that have contributed a lot to them for these projects. Mr. Tomblyn said they have looked at the plans for all these projects they want to do and they can't promise it will ever be self sufficient. He said the sewer line extension is being engineered by Mr. Swecker and for the bathroom renovations they are hoping for some private donations. They have had a lot of support and they are asking the County Commission for help to do the existing things that need done. Commissioner Taylor said the last 10 years that he has been on the Commission the Randolph County Recreation Board has come miles. Commissioner Scott said he has been told by the folks at the CVB that the new facilities have been bringing people in. Commissioner See said the board does a wonderful job and he thanked them for what they do. Commissioner Taylor said the Commission owns Camp Pioneer but they recreation board runs it. He said the Commission needs to step up to the plate and help out. Commissioner Scott moved to donate \$25,000.00 to the Randolph County Recreation Board for projects at Camp Pioneer and it is to be taken out of Hotel/Motel Tax funds.

Two of the Special Olympics athletes, Linda Teter and Timmy Wood, were present. Mrs. Wymer said they are grateful for what the County Commission has done for them.
