DISCUSS AND CONSIDER CHANGES TO ELECTION PRECINCTS, PROCESS, PROCEDURE FOR UPCOMING SPECIAL BOND ELECTION ON OCTOBER 7, 2017 AND RECONSIDER CLOSING OF THE COURTHOUSE ON FOREST FESTIVAL FRIDAY

County Clerk, Brenda Wiseman said she has been working on the issues with the precincts and has spoken with the Board of Education and several others about this. She said the Board of Education has agreed to let them use all of the schools as they normally do. She said with the closure however of Valley Head School and Homestead School those will not be available anymore. She said she spoke to the Tygart Valley Fire Department and they have agreed to let the County use their facility as a polling place for this election and all other elections. She said she spoke to Mrs. Matthew at the Valley Head Public Library and she has agreed to let them use the library as the polling place from now on also. Clerk Wiseman said the other three precincts in question for this election since it is being held on Forest Festival Saturday will be the Courthouse Annex, the Randolph County Community Arts Center and the Elkins Senior Center. She said she has spoken to the Mountain State Forest Festival Office and they have agreed to let us use the Phil Gainer Event Center (Old Armory) to house those three precincts this time. Commissioner See moved to permanently move Precinct 205 Homestead School to the Tygart Valley Fire Department.

Commissioner See moved to permanently move Precinct 215 Valley Head School to the Valley Head Public Library.
