CONSIDER APPROVAL OF INCREASE IN EXCISE TAX ON THE PRIVILEGE OF TRANSFERRING REAL PROPERTY PURSUANT TO 2017 REGULAR SENATE SESSION BILL 433, BEING WV CODE 11-22-2

Commissioner Scott said last week a public hearing was held regarding this issue. A few people came and asked some questions about it. The main thing they wanted to know was how much it was going to increase. He said the Commission has decided to raise it to \$5.50 per thousand. It is at \$4.40 per thousand right now and it has been since 1968. He said other counties have raised theirs to \$7.70 per thousand which is the maximum but they are not going to do that. Commissioner See said he feels it needs to be raised to cover costs. Commissioner Taylor said at the public hearing once they answered the people's questions they were satisfied. Commissioner Taylor read the order of adoption of excise tax increase out loud. Commissioner Scott moved to approve the order of adoption effective December 27, 2017 and this will go into effect on January 1, 2018. All yes—Motion passed unanimously

## CONSIDER CREATING ACCOUNT FOR FIRE FEE

Commissioner Taylor said we need to set up an account for the fire fee because the bills will be going out in January. Sheriff Mark Brady said we need to set up a fire fee account to have it separate. He said there will need to be \$1,000.00 put in to set it up. Bookkeeper Kitty Poling from the County Clerk's Office was present and said she doesn't know what account number to use for this. Sheriff Brady said they contacted the Auditor's office and was told to use 024 fund under special projects. Sheriff Brady said once the fees start coming in the \$1,000.00 will be reimbursed back to the County. Commissioner Scott moved to establish an account for the Fire Fee at Citizens Bank of West Virginia and to put in \$1,000.00 out of Courthouse Contractual to start the account. All yes — Motion passed unanimously
