MINUTES:

Commissioner Siler moved to approve the minutes from the special meeting that was held on January 31, 2023, for the Board of Review and Equalization, as submitted. All yes – Motion passed unanimously

Commissioner Siler moved to approve the minutes from the regular meeting that was held on March 16, 2023, as submitted. All yes – Motion passed unanimously

REPORTS:

Chris Lee, Assistant football coach for Elkins High School, appeared before the Commission along with two football players. He said they are going to have an overnight camp at Camp Pioneer for the football team. He said this will get the team together and foster relationships. He said it will be for two nights with two dinners and two breakfasts included. He said the cost to do this is going to be \$2,590.00. He said their goal is to raise all the funds so the kids don't have to pay anything. He said if they can't raise all the money they will charge each player \$30.00. He said this event will be June 29th and 30th and July 1st. He said any help the Commission could give would be appreciated. Commissioner Kesling said he would like to discuss it with Commissioner See but he doesn't think there will be a problem with giving them a donation. He said they will get back with them about it.

ITEMS FOR DISCUSSION/ACTION:

INFORMATIONAL PRESENTATION FROM RANDOLPH-TUCKER CHILDREN'S ADVOCACY CENTER

Margo Evick, Executive Director of Randolph-Tucker Children's Advocacy Center, appeared before the Commission. She said she was there to give a report to the Commission of their 2022 numbers. She said in 2022 the CAC saw 122 new children and provided advocacy services to 3,298 people. She said they also provide prevention in the classrooms. She said the majority of the cases they have are in Randolph County with only 15-20% in Tucker County. She said they have updated their advertising and will be having a Champions of Children event on April 28th. Commissioner Kesling thanked her for the job she does.

CONSIDER SIGNING PROCLAMATION FOR CHILD ABUSE PREVENTION AND SEXUAL ASSAULT AWARENESS MONTH

Commissioner Kesling read the Proclamations out loud which proclaims the month of April, Child Abuse Awareness Month and Sexual Abuse Awareness Month in Randolph County. Commissioner Siler moved to approve the Proclamations, as submitted. All yes – Motion passed unanimously

There were several people in attendance and photos were taken at this time.

CONSIDER RATIFICATION OF COMMISSION PRESIDENT'S SIGNATURE REGARDING ONE-TIME PAYMENT TO THE RANDOLPH COUNTY HUMANE SOCIETY

Tina Vial from the Randolph County Humane Society appeared before the Commission. She said they had over 60 additional animals brought to the shelter from an animal abuse case. She said many of the cats were sick and had to have veterinarian care, but none had to be euthanized. She said they are waiting to hear from the court before they can adopt them out. She said the community has been amazing with helping them. Commissioner Kesling said this was a horrific case. He said he heard that people came and dropped off blankets and other things. He said the Dog Warden told them the veterinarians stepped up too to help. He said the Commission wanted to help so they gave the Humane Society a check for \$5,000.00 for this legal case. He said that is the biggest case of animal abuse they have ever seen. Commissioner Siler said the bad thing is people think they are helping the animals when they do this, but they aren't. He appreciates the work the humane society has done. Commissioner Siler moved to ratify the Commission President's signature on the one-time payment of \$5,000.00 to the Randolph County Humane Society. All yes — Motion passed unanimously

CONSIDER APPROVAL OF PAYMENT FOR VETERINARY SERVICES RELATED TO ANIMAL SEIZURES

Commissioner Kesling said Allegheny Veterinarian Services did a great job with the animal abuse case and did like a drive thru service on all these animals. He said the bill is \$6,619.18 and that is for the initial seizure. Commissioner Siler moved to pay Allegheny Veterinarian Services \$6,619.18 out of Courthouse Contractual for the animal abuse and seizure case. All yes – Motion passed unanimously

CONSIDER RENEWAL OF MEMORANDUM OF UNDERSTANDING WITH THE RANDOLPH COUNTY HUMANE SOCIETY

Commissioner Kesling said this is something they do every year with the Randolph County Humane Society. He said this is for July 1, 2023 through June 30, 2024. He said the Commission gives them

\$80,000.00 in 4 installments of \$20,000.00 each throughout the year. Commissioner Siler moved to approve the memorandum of understanding with the Randolph County Humane Society, as presented. All yes – Motion passed unanimously

CONSIDER APPOINTMENT TO RUSSELL MEMORIAL PUBLIC LIBRARY BOARD

Commissioner Siler moved to approve the appointment of Sandra Bower to the Russell Memorial Public Library Board, to fill the unexpired term of Linda Zickefoose, who passed away. This term will start immediately and end on June 30, 2024. All yes – Motion passed unanimously

CONSIDER APPROVAL OF RESIGNATION FROM RANDOLPH COUNTY E911 ADVISORY BOARD

Commissioner Siler said Sergeant David W. Simmons from the West Virginia State Police has been transferred to Charleston, therefore he is resigning from his position on the Randolph County E911 Advisory Board. Commissioner Siler moved to approve Sergeant Simmons resignation, as submitted. All yes – Motion passed unanimously

CONSIDER APPROVAL OF VEHICLE PURCHASE FOR SHERIFF'S OFFICE

Randolph County Chief Deputy, Brad Sharp appeared before the Commission. He said they have been searching online for cruisers and have been having a hard time finding them. He said they found a 2023 F150 police responder at Jim Shorkey's in Pennsylvania that is Black. He said this would be to replace the cruiser that was totaled. Commissioner Siler moved to approve the purchase of a 2023 F150 Police Responder in the amount of \$49,488.00 and that is to be taken out of the courthouse equipment line. All yes — Motion passed unanimously

CONSIDER APPROVAL FOR THE SHERIFF OF RANDOLPH COUNTY TO BE APPOINTED OVER THE ESTATES OF VICTOR E. ARMSTRONG AND JOSEPHINE JODI WINGFIELD

Randolph County Fiduciary Commissioner, John Wallace IV appeared before the Commission. He said both of the estates on the Agenda today are unprogressed estates. He said the Clerk has sent out the notices and did the legal ad as required by law. He said the Victor Armstrong estate has claims pending that have not been taken care of by the Administratrix. He said he has tried to contact her with no response. He said the Josephine Wingfield estate is an old estate that has been going on since 2014. He said the first Fiduciary Commissioner, Thomas R. Ross, II did not advertise the estate because his bill wasn't paid. He said when the estate was turned over to him in 2020 it was advertised and a claim for approximately \$20,000.00 was filed by Davis Medical. He said he has spoken with the Administratrix on this estate several times but the claim has still not been taken care of.

Lisa Evix and her husband were present. Mrs. Evix spoke about the estate of her Mother, Josephine Wingfield. She said they just recently found out about the claim from Davis Medical Center and are trying to work it out with them. She said it was an oversight on her part. She said she didn't get two of the letters that Mr. Wallace sent but she got the third one. She said on March 3, 2023 she talked to Davis Medical Center and they agreed to release the claim against the estate and put a lien on the

property. She said her family resides in the home and purchased it along with her Mother so she doesn't want to have to sell it to pay the bill. Discussion followed.

Commissioner Siler moved to approve the Sheriff of Randolph County be appointed to complete the duties on the estate of Victor E. Armstrong. All yes – Motion passed unanimously

Commissioner Siler moved to table the decision on the Josephine Jodi Wingfield estate for 60 days. All yes – Motion passed unanimously

Commissioner Kesling said this is for the service on the 17 Generators that the County owns. The amount is \$30,600.00 for the year and this has already been budgeted for.
