Meeting called to order by Commissioner Kesling

PUBLIC COMMENT: None

#### MINUTES:

Commissioner Scott moved to approve the minutes from the regular meeting that was held on April 21, 2020, as submitted. All yes – Motion passed unanimously

#### REPORTS:

Sheriff Mark Brady reported that the work on updating the Sheriff's Office and Assessor's Office is continuing.

Deputy County Clerk, Karla Mahanes reported that the County Clerk's Office is working hard getting the absentee ballots mailed out. She said they have thousands to do. The last day someone can request one is June 3<sup>rd</sup>.

#### ANNOUNCEMENTS:

Commissioner Kesling announced that the Courthouse will be re opening on May 18, 2020 which follows the Governors guidelines.

Commissioner Kesling announced that a relative of two employees of the courthouse test positive for Covid 19. Those two employees test results came back negative but they are self quarantined for 14 days.

Commissioner Scott discussed the "Hero Pay". He said they have been talking to the Governor's Office and the US Treasury Office and also the Auditor's Office. He said they have actually changed the name from "Hero Pay" to a Covid 19 block grant. The reason why they are not calling it Hero pay anymore is because it cannot be used to pay any bonuses, any extra benefits that aren't already there, unless that would be a direct requirement for Covid 19. He said if the money is already budgeted to be used for the offices it also can't be used. He said there are three specific requirements under the cares act. Number one it has to be a necessary expenditure incurred due to the public health emergency with respect to Covid 19, also were not accounted for in the budget most recently approved at the time the emergency was declared which was the 16<sup>th</sup> of March for any direct expenditures. If it was not budgeted in the budget that was approved at the time which would be our current budget so if it was not budgeted it would be eligible and it was incurred during the period of March to December, 2020. It is doesn't fall under

those guidelines what the Commission is finding is that when they call they find it doesn't qualify. It is very limited as to what it can be used for and it's making it very difficult for the Commission. He said they would love to reward the front line workers but they can't because of the guidelines. He said they are using a lot of the money for PPE because a lot of organizations can't get it.

### ITEMS FOR DISCUSSION/ACTION:

CONSIDER DONATING A VEHICLE TO TUCKER COUNTY EMS

Sheriff Brady said Tucker County Commissioner, Lowell Moore, had contacted his office about this. He said Mr. Moore saw the decommissioned vehicles up at the new 911 Center and asked about getting one for Tucker County EMS. Sheriff Brady appeared before the Commission. He said he advertised and interviewed for the position of Court Security Officer and he would like to hire Kumar Lambert to begin working on May 18, 2020 with a starting salary of \$23,900 per year with full benefits. Sheriff Brady said they money is already budgeted for this position. He said this hire will bring him up to 4 full time and 2 part time Court Security Officers. Commissioner See moved to approve the hiring of Kumar Lambert as a full time Court Security officer for the Randolph County Sheriff's Office, as submitted.

They are requesting funding to recognize the Randolph County High School graduating seniors. These seniors have lost many privileges that comes along with being a high school senior. This is intended for every senior in both public and private schools within the County. With 269 seniors the cost will be \$8,408.00 for the banners and other expenses. Commissioner Scott said they are missing out on so many activities due to the virus. Commissioner Scott moved to approve a donation of \$1,000.00 to be taken out of courthouse contractual funds to support this worthy project.
