At a regular session of the County Commission in and for the aforesaid County and State, at the James F. Cain Court House Annex, on the 4th day of June, 2020 at 1:30 p.m.

Present: David Kesling, President of the Randolph County Commission and Chris See and Mark Scott Commissioners thereof.

Meeting called to order by Commissioner Kesling

#### PUBLIC COMMENT:

Phil Hudok appeared before the Commission. He said he appreciates the Commission having physical meetings. He said he wanted to address some concerns. He played some recorded clips regarding vaccinations. He said Allen Durshowiz the premier constitutional authority says the government has the right to force people to be vaccinated. He said he considers this subject to be very important. He said the government is giving hospitals money to treat COVID 19 patients even when not in need. He said you are not supposed to quarantine healthy people. He said there will be a lawsuit in the State of West Virginia regarding this. He has already consulted an Attorney. The lawsuit will be filed against the Governor. Mr. Hudok also discussed the government purchasing large amounts of rounds. He played a clip of Polk County Sheriff regarding the rioting where the Sheriff says that people should shoot anyone that tries to break in.

### MINUTES:

Commissioner Scott moved to approve the minutes from the regular meeting that was held on May 21, 2020, as submitted. All yes – Motion passed unanimously

#### REPORTS

Sheriff Mark Brady reported that all the construction has been completed and everything is running well. Everyone is back on staff and the public likes it very well. He said he wants to take care of the citizens of Randolph County and the staff that works here.

County Clerk, Brenda Wiseman reported on the upcoming Primary Election. She said as of this morning when she checked the reports, her office has sent out a total of 3,804 absentee ballots. Democrats that requested a ballot were 2,288, Republicans that requested a ballot were 946 and Independents and other parties were 570. She said so far they have received back 2,820 ballots. She explained that teams of democrats and republicans are entering those ballots into the voting system as they come in. She said any ballots received after Election Day will have to be brought to the canvass and once the Commission makes a motion to count those ballots they will then be entered. She said 914 people have voted during Early Voting so far. She said that includes the Mill Creek site and the Elkins site. She said Early Voting will end this Saturday June 6<sup>th</sup> at 5:00 p.m. She said on Monday June 8<sup>th</sup> will be supply pick up day for the poll workers then Tuesday June 9<sup>th</sup> is Election Day. She said all 27 precincts will be open as usual in

their normal locations. She said the polls will be open from 6:30 a.m. to 7:30 p.m. that day. She said they will be providing masks for all poll workers, hand sanitizer, Lysol wipes to wipe down the machines, gloves and pencils to use while voting. She said they are limiting it to only 4 voters in the room at a time. She said there will be social distancing signs in place at every precinct also. She said they are trying to do everything they can to try to keep everyone safe. She said on election night she plans to have the courthouse open for staff and for the public to sit outside on the courthouse lawn and the votes will be read out loud and copies will be provided to everyone periodically.
