He said as long as he has been Commissioner they have been receiving complaints about those roads. He said there are crater size pot holes, six to eight inches deep. He said there are some funds left in the coal severance funds so the Commission contacted Polino Contracting and received a quote to fix Orchard Street. He said some other side roads along that area have some pot holes and some in Highland Park that they will fix. The total cost is \$5,580.00. Commissioner Scott moved to approve the proposal for road repairs from Polino Contracting in the amount of \$5,580.00 and that is to be taken out of Coal Severance Funds.
