Randolph County Commission RE: Audit Committee

According to the West Virginia State Auditor's Office Chief Inspector Division, the Commission must appoint an audit committee prior to beginning the procurement process. This committee's primary responsibilities are to procure audit services and oversee corrective action associated with audit findings and concerns. Additionally, this committee shall have at least three members but not more than five with at least one member from the entity's governing body and one member being an entity appointee with a working knowledge of the accounting system utilized. The remaining one to three members may be appointed by the entity body as deemed appropriate. The Chief Inspector Division strongly recommends, but does not require, the third required member be a citizen of the government that is knowledgeable in the fields of accounting and auditing. Members of the audit committee shall be appointed by the entity body for a period of two years and one member of the committee shall be appointed by the entity body to serve as the primary contact person in the audit procurement process. The entity body may assign other powers and duties as deemed appropriate.

Therefore, the Randolph County Commission appoints the following to the audit committee:
