Chief Deputy, Bradley Sharp reported that the Sheriff's Office is currently accepting applications for Deputy. The deadline to apply is July 16th and applications can be picked up at the County Clerk's Office.

CONSIDER FUNDING REQUEST FROM HARMAN VFD FOR FIREWORKS DISPLAY

Patty Teter representing Harman Volunteer Fire Department, appeared before the Commission. She said for several years now the fire department has sponsored a fireworks event in Harman. This usually costs around \$5,000.00. They also allow others to come set up and have fundraisers at their facility. They also have a chicken BBQ, bouncy house for the kids, face painting and other vendors. They also serve refreshments after the parade. Commissioner See moved to approve the funding request in the amount of \$2,500.00 for the Harman VFD and that is to be taken out of Hotel/Motel Tax funds.

CONSIDER APPROVAL OF ENTERPRISE FLEET MANAGEMENT CONTRACT FOR COUNTY FLEET LEASING PLAN

Allan Brown from Enterprise Fleet Management appeared before the Commission. Commissioner Scott said the Commission has had several meetings regarding this and wanted Mr. Brown to come today to answer some questions they had. Mr. Brown said they are the largest renting and selling of vehicles company in North America and they have started a partnership with governmental agencies in West Virginia. He said this is a sustainable plan to have a fresher newer reliable fleet. He said this plan is poised to save the County \$150,000.00 over the next 10 years. This is open ended leasing and is not like a personal lease. Commissioner Scott said the County will have a dedicated account manager to work with them to keep up with the vehicles and make sure the fleet is kept the way it should be. They will advise them when it is time to sell a vehicle. Mr. Brown said the Sheriff's vehicles will arrive turn key with the letters, logos and equipment already on them. He said they have been doing police vehicles for other places. Commissioner Scott said they had Lisa Daniels-Smith check this out for the Commission and talked to Enterprise and also the City of Buckhannon who uses this system and she thinks it is a good idea. Commissioner See noted that the County Commission can only enter into a contract for one year at a time. Mr. Brown said this can be dropped if the Commission is not happy. He said nothing will have to be paid until a month after delivery. He said they will sell all of the unused vehicles. Chief Deputy Bradley Sharp asked if the Sheriff's Office could give Enterprise an equipment list? Mr. Brown said yes. Commissioner Kesling moved to approve the contract with Enterprise Fleet Management, as submitted.

CONSIDER FUNDING REQUEST FROM OLD BRICK PLAYHOUSE

Missy McCollam and several others appeared before the Commission. Mrs. McCollam said this is the 29th season for Old Brick Playhouse. She said they are currently holding summer camps for children. They have three camps divided up by age groups. She said they also do therapy sessions at ERCC. She said they have already sold 7,000 tickets for the Polar Express train rides in November and December. She said they also do a magic train show and murder mystery train rides. Commissioner See moved to approve the funding request in the amount of \$5,000.00 for the Old Brick Playhouse and that is to be taken out of Hotel/Motel Tax funds.

CONSIDER CLOSING TEEN COURT ACCOUNT

Commissioner Scott said this account was established by the previous Circuit Court Judge, Jaymie Wilfong. He said it was spear headed by Supreme Court Justice Brent Benjamin to get all the Counties to do this. Commissioner Scott said they are not using the account anymore and it still has money in it. He said they could use that money elsewhere, such as to help with the remodeling in the probation office. Commissioner Kesling moved to close the Teen Court account and to move the money from it into the General County account.

Commissioner Scott said the cameras have quit working in the probation office and they have approached Digital Soup about replacing them. He said Digital Soup can replace them with high quality cameras and recording system for \$2,775.00.

Commissioner See moved to approve the quote from Digital Soup in the amount of \$2,775.00 for cameras in the Probation Office.

Commissioner Scott said there is another budget revision here from the Sheriff of Randolph County. He said they have had several conversations with the Sheriff about this and have received legal advice from legal counsel. He said it is regarding longevity pay for the deputies. He said back in 2017 the Sheriff budgeted for an extra \$100.00 per year for his deputies for longevity pay which was approved by the Commission when they approved his budget. The Sheriff sent a request over to the payroll department asking for the \$100.00 a year to be paid all the way back to when each deputy started. Commissioner Scott said that is not what happened. The deputies received \$60.00 per year until 2017 and then from 2017 forward \$100.00 per year. Commissioner Scott said they had discussions with the Sheriff, he sought legal counsel and they sought legal

counsel and as a result of the Commission's legal counsels opinion he believes it should be continued as it has in the past. Commissioner Kesling said it needs to be put in the policy so this doesn't happen again. Commissioner See moved to deny the budget revision from the Sheriff's Office in the amount of \$3,000.00, that we spoke to him before about, and from the advice of legal counsel. All yes –Motion passed unanimously
