ITEMS FOR DISCUSSION/ACTION:

CONSIDER APPROVAL OF PART TIME HIRE FOR 911

Commissioner Scott moved to table this item.

All yes - Motion passed unanimously

CONSIDER APPOINTMENT TO RANDOLPH COUNTY BUILDING COMMISSION BOARD

Commissioner Scott said the Randolph County Building Commission is the organization that handles all the real estate transactions for the County so the County Commission needs to keep it active. There are a couple of vacancies on the board.

Commissioner Scott moved to approve the re-appointment of Mark Haddix to a three year term effective July 1, 2020 thru June 30, 2023.

All yes - Motion passed unanimously

Commissioner Scott moved to approve the re-appointment of Alfred Lewis to a two year term effective July 1, 2020 thru June 30, 2022.

All yes – Motion passed unanimously

CONSIDER APPROVAL OF REQUEST FOR PROPOSAL ON THE JAIL HOUSE ROOF PROJECT

Commissioner Scott said the Commission received an award for a Courthouse Facilities Improvement Grant in the amount of \$100,000.00 for replacing the roof on the jail. Commissioner Scott moved to advertise and accept bids for the Jail House roof project. All yes – Motion passed unanimously

CONSIDER APPROVAL OF MEMORANDUM OF UNDERSTANDING WITH HUMAN RESOURCE DEVELOPMENT FOUNDATION

Debbie Anderson with Human Resources Development Foundation was present. She said she would like to get some contact information for WV Department of Highways, and the town of Harman representatives and the OEM office. She said basically their work for the next three to six months will be in the Harman area. She said if there are any other places in the County that the County Commission knows of that needs work to please let her know. She said this is such a good program and it helps so many people. Commissioner Scott said the Commissioners and their Attorney have reviewed the Memorandum and Understanding.

Commissioner Scott moved to approve the Memorandum of Understanding between the Randolph County Commission and the Human Resource Development Foundation, as submitted. All yes – Motion passed unanimously

CONSIDER APPOINTMENTS TO RANDOLPH COUNTY AMBULANCE AUTHORITY

Commissioner See said two members have retired from the board. James McCloud served 41 years and Russell Linger, Jr. served 27 years. Commissioner See thanked them for their years of service.

Commissioner See moved to re-appoint four members to the Randolph County Ambulance Authority Board for three year terms beginning on July 1, 2020 and ending on June 30, 2023. Those four people are David Crawford, Mike Mullens, Belinda Toms and Merllene Yorkey. All yes – Motion passed unanimously

Commissioner Scott moved to approve the appointment of David Bobes to replace Russell Linger, Jr. on the Randolph County Ambulance Authority Board. This term will begin on July 1, 2020 and end on June 30, 2023. All yes – Motion passed unanimously

Commissioner Scott moved to approve the appointment of Jordan Godwin to fill the unexpired term of James McCloud on the Randolph County Ambulance Authority Board. This term will begin on July 1, 2020 and end on June 30, 2021. All yes – Motion passed unanimously

CONSIDER APPROVAL OF FIDUCIARY COMMISSIONER'S RECOMMENDATION ON THE ESTATE OF BETTY JEAN MATTHEW (See copy attached)

John J. Wallace, IV, Fiduciary Commissioner for Randolph County, appeared before the Commission. He said there was a claim/objection filed against this estate. He said a hearing was scheduled, but the claimant did not appear. He said he spoke with her some weeks later and told her he would reschedule the hearing upon her request. She has not contacted him to reschedule the hearing. His recommendation is for the claim/objection to be denied and for the estate to be closed per the final settlement that has already been filed.

Commissioner Scott moved to approve the recommendation of Fiduciary Commissioner on the estate of Betty Jean Matthew, as submitted. All yes – Motion passed unanimously

CONSIDER APPROVAL OF FIDUCIARY COMMISSIONER'S RECOMMENDATION ON THE ESTATE OF MILDRED RUTH WHITE (See copy attached)

John J. Wallace, IV, Fiduciary Commissioner for Randolph County, appeared before the Commission. He said Mrs. White passed away in March 2019. Her son Jerry White was appointed the Executor. There was a timely filed claim by George White which raised several matters and there was a hearing on that claim on June 28, 2019. Mr. White basically either withdrew all his claims or his claims were rendered unacceptable except for one which was a coal royalty that was to be paid to the estate of approximately \$14,000.00. There were five heirs and Mr. White said he was entitled to his one fifth share of that. Mr. Wallace said he issued a report to the Commission on that back in September 2019 basically saying yes he was entitled to it but no other heirs were because they did not submit a claim in a timely manner. He said there was a settlement filed with the Clerk on May 11, 2020 and then on May 19 & May 22 the other heirs filed objections saying that they wanted their share of the coal royalty. He said they did not file a claim within the time period to file claims and now they want to file a claim since the final settlement has been filed. He recommends that their claims be denied and the estate be closed.

Commissioner Scott moved to approve the recommendation of the Fiduciary Commissioner on the estate of Mildred Ruth White, as submitted. All yes – Motion passed unanimously

CONSIDER APPROVAL OF VEHICLE DONATION TO BELINGTON POLICE DEPARTMENT

Commissioner See said the Commission received a letter from the Belington Police Department requesting any assistance with a vehicle that the Commission could give. They are a small police department with a minimal operating budget and are unable to obtain a vehicle at this time. Commissioner Scott said he has talked to Mr. Himes from the Belington Police Department on a couple of occasions and he has spoken to Sheriff Brady about this also. He said there is an old ford expedition that is not in service by the Deputies and does not have a whole lot of value. Commissioner Kesling said we have already done this for Beverly and Tucker County.

Commissioner See moved to approve a vehicle donation to the Belington Police Department. All yes – Motion passed unanimously

CONSIDER RATIFICATION OF SIGNATURES FOR DEBT PAYMENTS

Commissioner Scott said at the end of the budget year we had a surplus in our Coal Severance funds. He said there are a couple of places that we still owe money. He said one is the substation for EMS out at Harman and also we still owe money on the 911 Center.

Commissioner Scott moved to ratify the signature of the County Commission President for the debt payments of \$50,000.00 for the Harman substation and \$50,000.00 towards the 911 Center, and that is to be taken out of Coal Severance Funds.

All yes – Motion passed unanimously
