Commissioner Scott announced that the County Commission signed a 72 hour declaration for a State of Emergency for the County and that is getting ready to run out so with the other Commissioners approval he would like to extend it to the end of the month. Commissioner Scott said the Commission received a request from the Randolph County Airport Authority. He said that Frank Heffernan has had some health issues and has requested to come off the board. The Randolph County Airport Authority has requested that the County Commission appoint Mark DeMotto in his place.

CONSIDER APPOINTING MEMBERS TO THE BEVERLY HERITAGE CONVENTION AND VISITORS BUREAU

Commissioner Scott said beginning July 1, 2019 the Beverly Heritage Center has met the requirements to be considered a true Convention and Visitor's Bureau in the County. He said as a result they will be receiving a portion of the 50 % of the Hotel/Motel Tax. He said they have asked that one of the County Commissioners serve on their board. Commissioner See moved to appoint Commissioner David Kesling to the Beverly Heritage Convention and Visitor's Bureau for a one year term beginning July 1, 2019 and ending December 30, 2019.

Commissioner See voted yes Commissioner Scott voted yes Commissioner Kesling abstained from voting Motion passed

CONSIDER SIGNING MEMORANDUM OF UNDERSTANDING WITH SUPREME COURT OF APPEALS FOR FAMILY COURT

Commissioner Scott said this is something the County Commission has been working on with the Supreme Court for about 6 or 7 months. They had sent the County Commission a request to sign a memorandum of understanding regarding the renewal of the Family Court lease. Commissioner Scott said the Commissioners had some concerns and questions that they sent back to the Supreme Court. As a result they sent the Commission a revised copy with amendments made and now the Commission is ready to approve it. Commissioner See moved to approve the signing of the memorandum of understanding with the Supreme Court of Appeals for the Family Court with the amended adjustments for the 2019/2020 Fiscal year.

CONSIDER FINANCIAL SUPPORT FOR BEVERLY FIREMAN'S FESTIVAL (See copy attached)

Commissioner Scott said the Commission received a request letter from the Beverly Fire Department, they are going to be having their annual community celebration, Beverly Days July 22nd through July 27th. They are asking for any support the Commission could give. Commissioner See said Beverly Fire Chief, Tim Harper, was going to come but with all the flooding and Beverly Fire Department collecting all the supplies to send over to Harman he couldn't come. Commissioner Scott said he wants to thank every single one of our volunteer fire departments for all their help. He said they have all been to Harman to help out. Commissioner See moved to approve funding for the Beverly Fireman's Festival in the amount of \$2,500.00 and that is to be taken out of Hotel/Motel Tax funds.

Commissioner See said the Commission asked Commissioner Kesling to reach out to Tom Hayward from Bowles, Rice regarding doing a 5 year strategic plan for the Commission. Commissioner Scott said Mr. Hayward did this plan for the City of Elkins and the Commission all looked at it and thought it was a good plan. Commissioner Kesling said about a month ago they had a conference call with Mr. Hayward because there are so many things they want to get accomplished down the road. He is willing to work with us on this and his fee for this 5 year plan is \$5,300.00. Commissioner Kesling

said he thinks this would help the Commission put down on paper the things they want to get accomplished. Commissioner Scott said part of the contract with Mr. Hayward is that he will consult with the Commission and make sure they are staying on track of what needs to be done. Commissioner Kesling said they would also take recommendations from County residents of what to put in the plan. Commissioner Scott said he will sit down with all the elected officials and get ideas of what they want to see accomplished and then he will bring that back to the Commission and they will go over it from top to bottom. Commissioner Kesling moved to approve the contract with Tom Hayward of Bowles Rice for the preparation of a 5 year strategic plan for a fee of \$5,300.00 and that is to be taken out of Courthouse Contractual funds.
