ITEMS FOR DISCUSSION/ACTION:

REVIEW PROPOSALS FOR ARCHITECTURAL AND ENGINEERING SERVICES FOR THE PROPOSED SITE OF THE 911 BUILDING

Commissioner See said they have two proposals. He said they are basically resume's and they will look them over and see who they would like to choose to do the potential designs for the new 911 Center. The first proposal is from VanNostrand Architects out of Buckhannon, WV and the second one is from Ceilings and Associates from Charleston, WV. Commissioner See moved to accept the two proposals, as submitted.

RECEIVE RESULTS FROM RANDOLPH COUNTY CLERK BRENDA WISEMAN REGARDING VERIFICATION OF SIGNATURES ON PETITION FOR COUNTY WIDE FIRE FEE/MOVE FORWARD WITH FIRE FEE PROPOSAL

Commissioner See said the number of registered voters that would be eligible to sign the petition for the county wide fire fee is 10,042. This number is from the last election that was held May 10, 2016 of registered voters in the County. Commissioner See said they would need to have 10% of those voters to sign the petition for the fire fee. The total number of verified signatures that have been turned into the Commission from the County Clerk's Office is 1,231. That is more than 10%. This is pursuant to WV Code 7-17-12. Commissioner Johns read the WV Code out loud. Commissioner See said that there will be a Class II Legal Advertisement put in the newspaper and anyone that wants to object to the fire fee has 45 days to object. There has to be a petition signed by 30% of registered voters for the objection, and these voters cannot be within the City of Elkins first due area and they cannot have already signed the other petition to have the county wide fire fee.

Commissioner Johns moved that the Commission move forward with the adoption of a county wide fire fee as outlined in WV Code 7-17-12 and that this Commission has been presented with the necessary signatures, 1,231 which meet the necessary 10% of qualified registered voters in the areas affected, and that the proposed ordinance be advertised as proposed by WV Code.

PROPOSAL FROM WOMEN'S AID IN CRISIS REGARDING COSTS FOR VICTIMS OF SEXUAL ASSAULT OR ABUSE

Mrs. Yokum, Jesse Massamino and Elizabeth Cain appeared before the Commission. Mrs. Yokum said the Prosecuting Attorney, Michael Parker received a letter from the WV Sexual Assault and Forensic Examination Commission. She said this commission was developed to get every county in the State in compliance with a Code that was passed and that each county would come up with a plan to serve victims of sexual assault. Randolph County did an assessment many months ago and came up with a gap in services for transportation. She said they have been working with the Randolph County Sexual Assault Response Team that meets monthly and what they have come up with is to come to the County Commission to seek funding for the Randolph County EMS to do the transports. She said we are one of three counties that will be submitting their plan first and it is due August 16th. She said the residents need transportation from Randolph County to UHC for forensic analysis. They went over the number of cases from January 2015 to December 2015. Commissioner Johns moved to allocate Women's Aid in Crisis \$3,000.00 for transportation and that is to be taken out of courthouse contractual funds. All yes—Motion passed unanimously

CONSIDER FUNDING REQUEST FOR SPECIAL PROJECT DURING 80TH MOUNTAIN STATE FOREST FESTIVAL

Breanna George, Executive Director of the Mountain State Forest Festival, appeared before the Commission. She said she was there to request funding for a new website and app. She said this will enable people to have information and details that are essential
