STATE OF WEST VIRGINIA RANDOLPH COUNTY COMMISSION SS:

At a regular session of the County Commission in and for the aforesaid County and State, at the James F. Cain Court House Annex, on the 16th day of August, 2018 at 10:00 a m

Present: Michael Taylor, President of the Randolph County Commission and Chris See and Mark Scott, Commissioners thereof.

Meeting called to order by Commissioner Taylor

PUBLIC COMMENT:

Tom Rennix, President of the Tygart Valley Homestead Association, appeared before the Commission. He said he was there to give an update on the association. He said they received their 501C3 designation on January 30, 2017. He said back when Homestead School was in operation they were working really hard to try to keep the school open. They held several fundraisers and tried to spread awareness of the situation at Homestead School. The school board did vote to keep the school open at that time but on March 1, 2017 a windstorm dislodged the gym roof and it fell over onto the cafeteria roof. This resulted in the closing of the school permanently. The board of education did repair the roof but the floors were badly damaged by water exposure. He said there was also vandals that got into the building and caused a lot of graffiti. The building was built in 1939 by the United States Department of Agriculture. The deed between the Department of Agriculture and Randolph County Schools stipulated that if the building was not used as a school building then the building and property would revert back to the United States Department of Agriculture. Mr. Rennix said they applied to the United States Department of Agriculture and Randolph County Schools and on January 17, 2018 Tygart Valley Homestead Association took over the ownership of the Homestead School Building and the property. Since that time with the help from a grant all of the roof has been repaired. They have been working on cleaning and painting inside the building. He said they plan to use the building and the grounds as a community center for the benefit of the public. They plan to have the gym repaired so they it can be used by sports teams for practices. Randolph County Schools has pledged to help them with the repair of the gym floor and cafeteria floor. They plan to use some of the classrooms as office space that will be available to rent. He said their biggest need is to have their electrical service disconnected and moved from the inside of the building to the outside of the building to be compliant with fire codes. They received some estimates for this work in the neighborhood of \$12,000.00. Once they have this corrected they will be able to allow larger groups of people into the building and they will be able to advertise for renting out the office spaces and that will get them on the road to be self sufficient. He invited everyone to come to their meetings. Mr. Rennix said any financial help would be appreciated and would go to a good cause.

ITEMS FOR DISCUSSION/ACTION:

REQUEST FROM MOUNTAIN STATE FOREST FESTIVAL TO USE FRONT LAWN OF COURTHOUSE AND PARKING LOT OF MAGISTRATE COURT DURING THE MOUNTAIN STATE FOREST FESTIVAL

Breanna George, Executive Director of the Mountain State Forest Festival appeared before the Commission. She said she was there to request approval to use the front lawn of the Courthouse and parking lot of the Magistrate Court during the festival. She said they have used the front lawn for several years but this will be the first time using the magistrate court parking lot for the tent for the princesses. The tent will be set up in the parking lot on Thursday and will be taken down before the following Monday. Commissioner Scott moved to approve the request from the Mountain State Forest Festival, as presented.

REQUEST FROM MOUNTAIN STATE FOREST FESTIVAL FOR FUNDING FOR A SPECIAL PROJECT FOR THIS YEAR'S FESTIVAL

Breanna George, Executive Director of the Mountain State Forest Festival appeared before the Commission. She said they would like to purchase more chairs and tables for the festival this year. She said if they purchase formal chairs for the distinguished guest dinner then they won't have to rent them. They are requesting \$5,000.00 for this project. Commissioner See moved to approve the funding request of \$5,000.00 for the Mountain State Forest Festival and that is to be taken out of Hotel/Motel Tax funds.

CONSIDER PROPOSAL FROM MT GENERATOR SERVICE AND UNIVERAL ENGINEERING REGARDING GENERATOR MAINTENANCE CONTRACT FOR VFD'S AND EMERGENCY SHELTERS IN COUNTY

Pat Smith from Mt Generator Service and Universal Engineering appeared before the Commission. He said this proposal has three sections to it. The first is the monitoring of the generators in which they can tell when batteries are dead and so forth. This is \$9,240.00 per year. The second is the generator servicing in which they check switches and oil and things of that nature and the cost for this is \$6,375.00 per year. The last is a repair of the generator at the senior center in Mill Creek. The automatic transfer switch function has failed. The cost to repair it will be \$3,800.00 and it will have a two year warranty.

Commissioner Scott moved to approve the monitoring contract in the amount of \$9,240.00 per year, as presented.

Commissioner See moved to approve the servicing contract for 16 units in the amount of \$6,375.00 per year, as presented.

Commissioner Scott moved to approve the repair of the automatic transfer switch on the Mill Creek Senior Center generator in the amount of \$3,800.00, as presented.

Commissioner See moved to approve the re-appointment of Betty Biggs to the Helvetia Public Library Board of Directors with a term ending on June 30, 2023.

CONSIDER REQUEST FROM ASSESSOR PHYLLIS YOKUM TO MAKE CHANGES TO CURRENT ERRONEOUS ASSESSMENT FORMS (See attached copy)

Randolph County Assessor Phyllis Yokum appeared before the Commission. She gave a copy of the new erroneous assessment form to the Commission for review. She said this is not a procedure change just a form change. She said that WV Code requires the erroneous assessments be approved by the County Commission and signed by the president of the County Commission, County Clerk and Prosecuting Attorney and then given to the Sheriff's Office to be processed. She said these form are on the new program they purchased from Global Science and Technology and they are computer generated and much easier to use and fill out. Commissioner See moved to approve the changes to the erroneous assessment forms, as submitted.

CONSIDER APPROVAL OF COMMUNITY CORRECTIONS GRANT BUDGET FOR 2019

Commissioner Scott said the North Central Community Corrections Board met to revise the 2018/2019 budget that the Governor awarded to them. There will be some forms coming in that need to be signed by the County Commission president. Those forms are not here yet but should be arriving in the next few days.

Commissioner Scott moved to give the County Commission President, Michael Taylor authority to sign the forms, when needed, regarding the North Central Community Corrections grant for 2018/2019.

CONSIDER HIRING OF THREE PART TIME EMPLOYEES AS 911 DISPATCHERS (See letter attached)

911/OEM Director, Cindy Hart appeared before the Commission. She said she has an employee leaving and she was already down one employee so she would like to hire three part time employees and get them started effective today. She said the first one is Charles B. Workman and he has already been trained so she would like him to start at \$12.34 per hour. This will be with no benefits. The second person she would like to hire is Chad F. Hawley with a starting salary of \$10.34 per hour with no benefits. The third person she would like to hire is Ramon Goux with a starting salary of \$10.34 per hour with no benefits. The positions are already included in her budget. She said they will be placed on 90 day probation period and will be kept at part time until she sees if they work out. Commissioner See moved to approve the hiring of the three part time dispatchers, as presented.
