Meeting called to order by Commissioner Kesling

PUBLIC COMMENT: None

MINUTES:

Commissioner Siler moved to approve the minutes from the regular meeting that was held on August 17, 2023, as submitted. All yes – Motion passed unanimously

#### **REPORTS:**

Robert Daman from the 911/OEM Office appeared before the Commission. He said they have 2 water buffalo's in use right now, one at Coalton School and one at Revelle's Campground. He said they are having water issues and he said they will check back with them the first of the week and see if they are done with them. He said they are waiting to see where they are at with rebuilding the pump station. He said they are still working on the generator issue at Rich Mountain. He said the tower at the 911 Center is still in limbo with what to do but it will probably have to be dropped down some.

Brooke Hinzman reported on the Pool. She said the new slide has been ordered and it will have to be shortened by 2 feet to fit where they want it and the cover has been ordered and it will be cut out to go around the slides. She said they are hoping to get it all done by the end of this week so they can get it winterized.

Sheriff Elbon reported that the last Ford 150 Truck is in service as of yesterday. He said it is equipped very well and is a sharp looking truck. He thanked the Commission for getting it for his office. He said they have been running into radio issues with the new hires. He said the radios his officers are using now are becoming obsolete. He said you can't even get parts for them now. He said he submitted some paperwork for the Commission to review and see if Peggy Ross can start looking for some grants to get new ones. He said they need at least 6 right now.

Commissioner Kesling said the Commission received a letter from Valley Head Community Center thanking them for their funding.

ITEMS FOR DISCUSSION/ACTION:

INFORMATIONAL PRESENTATION FROM THE WVPSC REGARDING HARMAN AND WHITMER WATER SYSTEMS

Brooke Hinzman said they called and said they would not be able to attend the meeting today. Commissioner See moved to reschedule Item A. All yes – Motion passed unanimously

CONSIDER APPROVAL OF FUNDING REQUEST FROM ELKINS VOLUNTEER FIRE DEPARTMENT (See copy attached)

Commissioner Kesling said the Commission received a letter from the Elkins Volunteer Fire Department asking for funding to help with the Mountain State Forest Festival Fireman's parade. He said they provide food for 200-300 firemen, trophies, awards etc. Commissioner Siler moved to approve the funding request from the Elkins Volunteer Fire Department in the amount of \$1,500.00 and that is to be taken out of Hotel/Motel tax funds. All yes – Motion passed unanimously

CONSIDER APPROVAL OF FUNDING REQUEST FROM LEADING CREEK FIRE DEPARTMENT (See copy attached)

Lutecia Fidler appeared before the Commission on behalf of the Leading Creek Volunteer Fire Department. She said fire chief, Branson Henry, could not attend today. Ms. Fidler read a letter out loud from Mr. Henry. She said they need help in purchasing 16 SCBA (Self Contain Breathing Apparatus) and 16 spare cylinders to equip their fire engines. She said their current SCBA's are out of date. She provided a quote to the Commission in the amount of \$125,660.00. Commissioner Kesling said they have already been approached by other volunteer fire departments and have given them some funding and the Commission wants to keep it equal to all fire departments. Commissioner Kesling moved to approve the funding request from the Leading Creek Volunteer Fire Department in the amount of \$14,900.00 and that is to be taken out of courthouse contractual funds. All yes – Motion passed unanimously

CONSIDER APPROVAL OF NEW HIRE FOR RANDOLPH COUNTY ASSESSOR'S OFFICE ( See copy attached)

Randolph County Assessor, Phyllis Yokum appeared before the Commission. She said she would like to hire Danielle Hartley to fill a full time benefited clerk position in her office. She would like her to begin working on September 11, 2023 with a starting hourly wage of \$12.83 per hour and that is to be paid out of her regular county budget in which she already has the money in there for. Commissioner See moved to approve the hiring of Danielle Hartley as a full time benefited clerk in the Assessor's Office with a starting date of September 11, 2023 and with a starting wage of \$12.83 per hour. All yes — Motion passed unanimously

#### CONSIDER APPROVAL OF NEW HIRE FOR RANDOLPH COUNTY 911 CENTER (See copy attached)

Robert Daman from the 911/OEM office appeared before the Commission. He said they would like to hire Christopher Wymer as a telecommunicator trainee. This is a full time benefited position with a probationary period of 6 months. His starting pay would be \$12.86 per hour and they would like him to begin working on September 11, 2023. The current budget covers his wages. Commissioner See moved to approve the hiring of Christopher Wymer as a 911 telecommunicator trainee, as presented. All yes – Motion passed unanimously

CONSIDER APPROVAL OF WAGE ADJUSTMENT FOR 911 CENTER (See copy attached)

Robert Daman from the 911/OEM office appeared before the Commission. He said they would like to raise the pay of Nicholas Harris. He is now operating on the floor as a stand-alone telecommunicator and they would like to change his pay from \$13.25 per hour to \$13.97 per hour. These wages are covered in the current budget. Commissioner See moved to approve the pay adjustment for Nicholas Harris, as presented. All yes — Motion passed unanimously

CONSIDER APPROVAL OF APPOINTMENTS TO THE RANDOLPH COUNTY UNSAFE BUILDINGS AND LANDS ENFORCEMENT AGENCY (See copy attached)

Commissioner Siler said there are some terms that expired at the end of August on the Unsafe Buildings and Land Enforcement Agency, so the Commission needs to get those people re-appointed. Commissioner See moved to reappoint Ray Lamora and J.W. Jones for a term starting immediately and ending on August 31, 2024. All yes — Motion passed unanimously. Commissioner See moved to reappoint Peggy Young-Ross, Keith Brown, Rob Elbon, Samantha Beaudoin and John Hempel for terms beginning immediately and ending on August 31, 2025. All yes — Motion passed unanimously

CONSIDER APPROVAL OF RESOLUTION REGARDING EDWARD BYRNE MEMORIAL JUSTICE ASSISTANCE GRANT (See attached copy)

Peggy Young-Ross appeared before the Commission. She said this is a grant she is applying for in the amount of \$15,650.00 with a match of \$5,217.00 She said it would be used for magnifiers for pistols for the Sheriff's Office. Commissioner See moved to approve the Resolution, as submitted. All yes — Motion passed unanimously

CONSIDER APPROVAL OF RESOLUTION REGARDING JUSTICE AND COMMUNITY SERVICES GRANT (See copy attached)

Peggy Young-Ross appeared before the Commission. She said this is a grant she is applying for to be used for the Task Force. She said the Commission would just be a pass thru agency on this one as it is for overtime for the task force officers in other counties, not Randolph. She said it would be in the amount of \$57,000.00 and each County would provide their own cash match. She said Randolph counties task force overtime is already covered by another grant they already received. Commissioner See moved to approve the Resolution, as submitted. All yes – Motion passed unanimously

CONSIDER APPROVAL OF RESOLUTION REGARDING WV RECORDS MANAGEMENT AND PRESERVATION BOARD GRANT (See copy attached)

Peggy Young-Ross appeared before the Commission. She said this is a grant she is applying for to be used for labor for the County Clerk's Office to get rid of some old boxes of documents located in the old jail building. Commissioner See moved to approve the Resolution, as submitted. All yes – Motion passed unanimously

Peggy Young-Ross went over the grants that are still open for the County. Commissioner Kesling discussed space for the new Judge that will be starting January 1, 2025. He said they have Peggy looking for grant money to help with that. He said his big project for next year is to renovate the old jail. Peggy Young-Ross said the new Judge has to have a completely stand alone courtroom. Commissioner Kesling said they were thinking that the old Prosecutor's Office could be the new Judge's Offices and the Commission meeting room could be used as the new courtroom. He said nothing has been decided yet, just thinking about different ideas.

Sheriff Elbon appeared before the Commission. He said his office would like to have a general contract line in the budget and payroll for contracting work at the ball games or even Wal-Mart. He said this contract is with Elkins High School and they would write the check to Randolph County and that would be deposited in the line and then payroll department pays the Deputy. Commissioner Kesling said they spoke to the Auditor's Office about this and was told it was okay to do it. Commissioner See moved to approve the security contract with the Randolph County Sheriff's Office and the Elkins High School, as submitted. All yes – Motion passed unanimously
