Curt Gainer from the Randolph County Emergency Squad reported they hired another Paramedic/EMT and that will staff four ALS units in the County and that will start on September 10, 2018 and they have also purchased another ambulance and that should arrive next week.

OEM/911 Director Cindy Hart reported that the work at the new 911 Center is all on track. She said every time she goes up there she is amazed at the work that has been done.

Erin Golden, Director of North Central Community Corrections, reported that there are currently 117 participants on the program and the program has saved the County \$364,287.50 in regional jail bills so far this fiscal year. (See attached copy)

ITEMS FOR DISCUSSION/ACTION:

CONSIDER FUNDING REQUEST FROM MOUNTAIN MODEL A CLUB FOR A MODEL A NATIONAL TOUR EVENT TO BE HELD IN ELKINS (See attached copy) Donald L. Trimble, Co-Chairman of the Mountain Model A Club, appeared before the Commission. He said this club, which is a region of the Model A Restorers Club, is hosting a national tour in Elkins this year. This will be the first Model A Restorers Club National Event to be held in West Virginia. This will be the 90th anniversary of the Model A Ford which makes it even more special. The event will take place September 17, 2018 thru September 20, 2018 and there will be approximately 350 people attending. Mr. Trimble said all of the hotels in Elkins will be full and some people will have to stay in Buckhannon. This has been advertised in magazines that have been sent out nationwide. This will bring a lot of attention to Elkins. There will be 20 States represented. Mr. Trimble said they are requesting funding to be able to enhance the experience of those coming for the Tour. They plan to take them to different areas around the County and on a train ride. Commissioner Scott moved to approve \$2,000.00 out of Hotel/Motel Tax funds to the Mountain Model A Club for their national event to be held in Elkins.

CONSIDER APPROVAL OF AIA DOCUMENT FROM SILLING ASSOCIATES FOR FURNITURE, FURNISHINGS AND EQUIPMENT FOR THE NEW RANDOLPH COUNTY 911/OEM CENTER

OEM/911 Director, Cindy Hart appeared before the Commission. She said this is an additional contract that the Commission knew was coming. This has already been included in the loan and it's for furniture, furnishings and equipment. She said they went with functionality of it and did not get the most expensive. The contract said not to exceed \$400,000.00 and it will not be close to that, she said.

Commissioner Scott moved to authorize the Commission President to sign the AIA documents from Silling Associates for the FFE at the new 911 Center.

CONSIDER REQUEST FROM BEVERLY FIRE DEPARTMENT FOR A ONE DAY BEER PERMIT FOR EVENT TO THE HELD ON SEPTEMBER 15, 2018 Commissioner See said the Beverly Fire Department contacted the Commission about getting a letter from the Commission for a one day beer permit for their gun bash on Saturday September 15, 2018. He said no one was present to speak about this and they did not send in a letter regarding it, but since the event is going to be held before the next commission meeting the Commission needed to take action. Commissioner Scott moved

to approve writing a letter on behalf of the Beverly Fire Department for a one day beer permit, as requested.

All yes - Motion passed unanimously

CONSIDER APPROVAL OF A LETTER OF SUPPORT TO THE ADRIAN PSD FOR A WATER LINE EXTENSION IN THE PICKENS AREA (See copy attached) Commissioner Scott said in early 2017 he was approached by some Pickens community residents wanting water service to their area. He said he was told that about ten years ago they had tried to get water service from the Adrian PSD but the funding was not available. Commissioner Scott said he started talking to the Adrian PSD and Shane Whitehair about this. He said they were working on a project in the Upshur County area at the time and he asked about getting involved in that project. Commissioner Scott said there was a public meeting with the residents of Pickens and around 75 to 80 of them signed up and paid their fee to have that area included in the project, if possible. He said the Commission received a letter from Adrian PSD that says they are including the community of Pickens in the water line extension project. Adrian PSD is submitting an application to USDA Rural Development for a loan in the amount of \$4,900,000.00 and a grant in the amount of \$3,700,000.00 with expected local grant funding in the amount of \$75,000.00. Commissioner Scott said that Upshur County has approved the project but Randolph County needs to approve it also.

Commissioner Scott moved to provide a letter of support to Adrian PSD for water line extension into the Pickens area.

All yes - Motion passed unanimously

CONSIDER APPROVAL OF FUNDING FOR A JOBS COORDINATOR FOR RANDOLPH COUNTY SCHOOLS (See copy attached)

Commissioner Scott said last year Randolph County Schools had a WV Graduates for Job specialist that worked with at risk students at the Randolph Technical Center. This year the funding has been cut. Randolph Technical Center, Principal/CTE Director John Daniels sent the Commission a letter that they would like to continue with this program and asked for funding assistance. Last year the Commission gave \$5,000.00 for this position and Randolph County Schools matched the donation. Commissioner Scott moved to approve \$5,000.00 out of courthouse contractual funds for the jobs coordinator for Randolph County Schools, as requested.

By its very name, Randolph County CVB represents all venues and attractions in Randolph County and has no affiliation to any one attraction. We work with and promote all areas with attractions including Historic Beverly, Helvetia, and the City of Elkins.

The Randolph County CVB is overseen by, and responsible to, a board of directors consisting of local attraction and venue owners and members of county and municipal offices.

What's the importance of the Randolph County CVB?

The marketing and promotional efforts, created by the Randolph County CVB, are instrumental in attracting thousands of visitors to the area. Its offices and Visitor Center, on Randolph Avenue Rte. 219, is often the visitor's initial stop for information on Randolph County and its attractions. The Visitor Center is an important part of the program as it provides detailed, professional assistance through experienced and knowledgeable staff. The continued staffing with professional and experienced personnel is imperative to maintain its effectiveness.

The Randolph County CVB Visitor Center and RCCVB office is important to the county because it:

- Greets just under 20,000 sign-in visitors. We do not count bus tours as we fund efforts to get the tours here and they do not have to stop at our center. They go directly to their destination as their bus tour package has completed prior to their arrival.
- Takes over 20 telephone calls daily on out toll-free line requesting information on Randolph County attractions.
- Prepares and distributes hundreds of area promotional packages for conferences, conventions, tour bus groups, wedding planners and family reunions.

- Is the Hub for the promotion of all county attractions, festivals, venues, lodging, restaurants
- Maintains and updates the official Randolph County website and promotes the county through Facebook and our on-line Constant Contact newsletter.
- Creates the Promotional literature, advertisements and coordinates the consumer and travel show participation that is so important to attracting visitors and conventions to the County.
- Coordinates sponsorships and provides advertising funding to many local organizations and events.
- Maintains memberships in various tourism organizations including: The West Virginia Hospitality and Travel Association, Elkins Main Street, Elkins-Randolph County Chamber of Commerce, West Virginia Mountain Highlands, and West Virginia Group Travel Association.

The Randolph County CVB has worked hard on keeping its on-line presence active and up-to-date. We constantly update the website and promote it everywhere in

In 2014, we updated the website to its current look and its history has been as follows:

2014 - 11,191 visitors with 85.6% new visitors with 41,224 pages viewed

2015 - 15,624 visitors with 85.7% new visitors and 57,246 pages viewed

2016 - 18,173 visitors with 85.3% new visitors and 61,147 pages viewed

2017 – 14,999 visitors with 85.0% new visitors and 49,555 pages viewed (*)

(*) You should note the visitor decrease of almost 18% from 2016 to 2017 which we feel is a direct result of the loss of funding because of lost revenue due to non-collections of the lodging tax in 2016 and RCCVB defunding in 2017 which curtailed our ability to advertise and promote.

Facebook and Constant Contact Reach

Our efforts on Facebook are expanding and we see increases in social media. We have been continuing to post items several times a day and would like to get back to that schedule. Our Facebook fans have increased as follows:



Dear Commissioner Taylor:

Adrian Public Service District is planning a project to replace some undersized waterlines within its system, as well as booster station upgrades. However, the biggest part of the project is to also extend water to approximately 166 potential customers, including the community of Pickens. This project will improve water service reliability and pressure for many of the existing customers as well as extend water to new customers who have requested it. The estimated total project cost is approximately \$8,675,000.

Adrian PSD is submitting an application to USDA Rural Development for a loan in the amount of \$4,900.000 and a grant in the amount of \$3,700,000, and there is expected to be \$75,000 in local grant funding.

It is our understanding that geographically it is unfeasible and impractical for Pickens to be served by any Randolph County entity.

We are asking for Commission approval to proceed with the planned extensions. We would appreciate having your comments as soon as possible, because we anticipate submitting the application later this month.
