Randolph County Assessor, Phyllis Yokum reported to the Commission that as of right now she has two hearings that will need to be held in October for the board of assessment appeals. North Central Community Corrections Director, Erin Golden appeared before the Commission. She said they currently have 114 on the program and the program has saved the County \$429,618.00.

Sheriff Mark Brady reported that the mobile command unit is down. He said they took it to Roy's RV for repair of the generator, steps and a leak but now the air suspension it out of it. He said it is now at Elkins Truck Service and he doesn't know how much this is going to cost. He also reported that the kitchen in the old jail has been mostly remodeled now. He said they are just waiting for the doors and flooring to be done. He said they also put a new bathroom in. He said it looks really good and he is pleased with the work.

INFORMATIONAL PRESENTATION: BRIDGETTE COOK FROM GOV.SPEND Bridgette Cook did not appear at the meeting.

### INFORMATIONAL PRESENTATION: KURT BARKLEY, THE ARTS CENTER (See copy attached)

Kurt Barkley, Executive Director of the Randolph County Community Arts Center appeared before the Commission. He said the Randolph County Community Arts Center is a 501C3 charitable non-profit organization incorporated in 2001 with the mission to take a leadership role in the cultural life of our region by providing facilities and programming that will educate and inspire all of our citizens. He said for over 18 years the Arts Center has been providing art and music education, concerts, high quality art exhibits, cultural events and civic meeting space for our part of West Virginia. He said this is for young and old. He said they now have a full time stain glass studio and have 12 brown bag concerts throughout the year that are free to the public. He said last year 4,200 people came through their doors. The forest festival brings 2,500 - 3,000 people in to see the exhibits. He said they have two full time employees and a part time custodian and lots of volunteers. Mr. Barkley said he wants to add outreach to the elementary schools in all of Randolph County. He wants to send artists or performers to the schools. He said this past year they became part of the bus tour program and will have 10 buses come by the end of the year. He said this way the people can come and do a train ride and have dinner and come to the Arts Center for a performance. He said they are already booking buses to come in 2020. Mr. Barkley said they are reaching out for assistance and are asking for a donation of \$5,900.00 for the outreach program. He said they do get funding but it has been cut in the last four years by 50%. Commissioner See moved to approve the funding request in the amount of \$5,900.00 for the Randolph County Community Arts Center and that is to be taken out of hotel/motel tax funds.
