#### REPORTS:

North Central Community Corrections Director, Erin Golden appeared before the Commission. She said there are currently 94 participants on the program has saved the county \$448,337.75 in regional jail fees so far this fiscal year.

County Clerk, Brenda Wiseman reported that early voting for the General Election will begin on October 26, 2016 and run through November 5, 2016. She said the last day to register to vote or make any changes to your voter's registration record is October 18, 2016. She said they will begin testing the voting machines next week.

OEM/911 Director, Cindy Hart reported that the Office of Emergency Management applied for a grant for approximately \$300,000.00 for mobile and portable radios for fire departments and EMS. She said she received a letter back saying that they will be receiving a grant of \$55,000.00. The portables were cut out 100% and the mobiles went down from five to two for each department. She said many counties got cut 100%. This cost also includes the antenna and installation so there is no cost to the departments at all. She said she will apply again next year for this grant.

She said this will take approximately 8-12 weeks and the cost is \$25,000.00. Commissioner Taylor said we have been working on this a long time and this will give them a solid estimate of what it is going to take to renovate the building. The cost will come out of 911 fees. Commissioner See moved to approve the signing of the contract with Silling Architects to move forward with Phase I of the project.
