PUBLIC COMMENT:

Mike Rezac from West Virginia Risk Pool, appeared before the Commission. He said he was there just to check in and give an update to the Commission about their services. He said they now have 49 of the 55 counties enrolled in the risk pool. Brooke and Monongalia counties recently joined, he said. Mr. Rezac said the West Virginia Risk Pool is always happy to help out with trainings, policies etc. He said they can come and do a walk thru for safety risks also.

Erin Golden, Director of North Central Community Corrections, appeared before the Commission. She said there are currently 103 on the program and the program has saved the County \$638,878.25 in regional jail bills so far this fiscal year.

County Clerk, Brenda Wiseman gave a report on the Election. She said early voting is going on right now and as of the end of the day yesterday there were 2,448 voters. She said that is already 368 more than the total number of voters that voted early during the primary election and there are still three more days to go.

Commissioner Taylor said WV State Code requires that the County Commission have a meeting every three years with all the wrecker services in the County to discuss policies and procedures. That meeting has been scheduled for Thursday November 15, 2018 at 11:00 a.m. in the Commission meeting room and it is a public meeting.

ITEMS FOR DISCUSSION/ACTION:

CONSIDER DONATION FOR ELKINS ANNUAL CHRISTMAS PARADE (See attached)

Mike Bell, President of the Elkins Randolph County Chamber of Commerce appeared before the Commission. He said they are respectfully requesting a donation in the amount of \$3,000.00 for the Elkins Christmas parade. He said this year's theme is "It's a Holly Jolly Christmas" and they anticipate more than 50 individual units, local businesses and community organizations to participate in the parade. He said after the parade the children can go to the YMCA to see Santa and get hot chocolate. He said it's a great community festive occasion and a long standing tradition. He said the chamber's budget this year is just over \$92,000.00 and they look to the Christmas parade to net and those proceeds go towards their programs. He said next week they will conclude their second pathway to leadership series, this is a four week class for emerging leaders and local businesses that covers communication, emotional intelligence, team building and these are the attributes and skills that leaders need to help our local businesses thrive. Mr. Bell said they are also sending two members of their workforce development committee to Little Rock, Arkansas next week and then again for two days in January to participate in the ACT Work Ready Communities boot camp. He said they want to find out what the gaps are between what our employers need and what we have prepared so they can connect those gaps. They can give us some plans of what has worked in some other cities and counties. He said they are also very excited to announce that Lisa Wood has been named as the new executive director of the Elkins Randolph County Chamber of Commerce and she will begin on November 7, 2018. He said the date of the Christmas parade is Wednesday December 5th with a rain date of Friday December 7th. Commissioner See moved to approve a contribution of \$3,000.00 to the Elkins Randolph County Chamber of Commerce for the annual Christmas Parade and that is to be taken out of Hotel/Motel Tax funds.


