CONSIDER FUNDING REQUEST FROM ELKINS DEPOT CVB

Anne Beardslee and Morgan Glopp appeared before the Commission representing Elkins Depot Welcome Center CVB, Inc. Ms. Beardslee said there was a break in and some Christmas lights were damaged and they stole ramps and rails t-shirts. She said this summer they had three visitors from Roadrunner Magazine. The magazine is going to do an article featuring motorcycling trips out of Elkins. This will be done in the March/April edition. She said the CVB would like to do a full page full color advertisement in this magazine. She said their marketing budget dropped \$71,000.00 because of COVID. The cost for this ad would be \$3,915.00. She said they would also like to advertise in Blue Ridge Country Magazine and the cost of that ad would be \$4,495.00. She said they would also like to advertise in West Virginia Living magazine and the cost of that ad would be \$1,800.00. She said the Polar Express train has been cancelled this year and only 7 or 8 trains ran out of Elkins this year and those were ones with groups that were already booked. Commissioner Scott moved to approve the funding request, as submitted, for advertising. This is to be taken out of the other 50% Hotel/Motel Tax funds.

Commissioner Scott moved to approve the hiring of James "Turk" Ramsey with a starting salary of \$28,500.00 per year with full benefits and he will begin working on November 16, 2020. that needed done he always did it without being asked. There will be a retirement party tomorrow November 6^{th} from 11:30-1:30 here in the meeting room.
