Commissioner Taylor said this is something the Commission does every year for the Randolph County Development Authority to designate them as the lead economic development organization in Randolph County. CONSIDER CONTRIBUTING TO THE TYGART VALLEY HOMESTEAD ASSOCIATION FOR UPDATING ELECTRICAL WORK AT HOMESTEAD SCHOOL

Commissioner Scott said Mr. Rennix from the Homestead Association came to the Commission a few meetings ago and presented some repairs and upgrades that needed to be done to the Homestead School. He gave the Commission, at the time one estimate for the electrical upgrades and they asked him to get a second estimate, which he did. Mr. Scott said since then the Commission has heard from the school board that they are getting ready to do a walk thru of Homestead School because one of the basketball teams from up the valley is going to start practicing there once it gets approved. Commissioner Scott said he recommends this be tabled until the next meeting so that they can find out more fully exactly what all needs to be done from the Fire Marshall in order for them to be able to occupy that building. Commissioner Scott moved to table this item until the next meeting.

CONSIDER HELP IN FUNDING FOR ANNUAL CHRISTMAS DINNER AT MILL CREEK

Kaitlynn Bolyard appeared before the Commission. She said she was there on behalf of her grandfather Nick Taylor and Tygart Valley Fairs and Festivals. She thanked them for their continued support of their community activities. She said this year their annual free community Christmas Dinner will be held at the Mill Creek Senior Center on December 15th from 11:00 a.m. to 3:00 p.m. She said please consider their request for \$5,000.00 to help with their community events. She said they also donate towards funerals and also donate hams to all of the cakewalks and auctions in their local area. She said the second page shows what their past donations have been spent on. Commissioner Taylor said

they appreciate what they do and sometimes it's the only good hot meal that some of those folks get for Christmas. He said it is a worthy cause. Commissioner Scott said the total cost for the event appears to be around \$3,200.00 and he asked what the rest of the money would be used for? Ms. Bolyard said it would be put towards the mother's day celebration and other events they have. Commissioner Scott said they normally come and ask for funding for each event separately. Commissioner Scott moved to approve a contribution of \$3,500.00, out of Hotel/Motel tax, to the Tygart Valley Fairs and Festivals annual Christmas activities.

CONSIDER HELP IN FUNDING FOR A TRACTOR FOR RANDOLPH COUNTY RECREATION BOARD

Commissioner Taylor said the Randolph County REC Board made a presentation to the Commission a couple of meetings ago regarding assistance in helping purchase a tractor. He said they did advertise in the paper, as required. They only received one bid back and that was from Schrock Farm Equipment out of Oakland, Maryland. The total cost with everything is \$32,500.00. Commissioner Scott said this bid that came back was for a smaller tractor than what they originally asked for. He said the Commission went back to the REC Board and asked if it was going to be big enough and have all the equipment that is needed. He said the REC Board said it would be adequate. Commissioner Scott said the Commission cannot fund the entire cost of the tractor and the REC Board has came up with \$15,000.00 and asked if the Commission could help with the rest. Commissioner Taylor said the County Commission owns Camp Pioneer. Commissioner See said it is a necessity to keep the grounds looking nice. Commissioner See moved to fund \$17,500.00, out of coal severance, to the Randolph County REC Board towards the purchase of a new McCormick Tractor.

CONSIDER FUNDING REQUEST FROM MOUNTAIN ARTS DISTRICT (See attached)

Scottie Roberts Wiest and Pat Schoonover appeared before the Commission. Ms. Wiest spoke to the Commission and thanked them for their past support. She said their website is up and going successfully and they are providing workshops for local artists. She said they are doing public art on the bathrooms at the Park and plan to do other public art projects. She said they are working with Old Brick Playhouse and others to try to do clustering designation for tourism. She said there is an interest in public art. Pat Schoonover said they have only been a non-profit organization for the past three years and she feels like they have done a lot in that amount of time. She said they are not the only ones out there trying to bring art and tourism to our area. Commissioner Taylor said he would like to see them reach into the outer areas of the County also. Ms. Schoonover said they have young people coming to them from all over the County, not just Elkins. Ms. Schoonover said they were there today to ask for \$3,000.00 for the marketing of the website and to do other projects. Commissioner See moved to approve the funding request in the amount of \$3,000.00, to be taken out of Hotel/Motel Tax, for the Mountain Arts District.

CONSIDER FILING A FORMAL COMPLAINT WITH PUBLIC SERVICE COMMISSION AGAINST FRONTIER COMMUNICATIONS

Commissioner Scott said over the course of the last 6-9 months the Commission has been getting a lot of complaints from people about their phone service. He said a lot of the complaints have been coming from the 304-339 numbers. When Frontier is called about a problem they respond to the person's house but never seem to be able to fix the problems. Commissioner Scott said the problem is with the main lines. He said he checked into the process and found that they can file a complaint with the Public Service Commission against Frontier Communications. Commissioner Taylor said unfortunately sometimes that is what it takes to get them to do something. He recommends drafting a letter to send to the public service commission. Assessor, Phyllis Yokum said her brother lives on Middle mountain and has been having trouble with his phone for three weeks now. This is happening all over the County not just up the valley.

Commissioner Scott moved to authorize President Taylor to sign a letter of complaint to the Public Service Commission regarding Frontier Communications.



Dear Commissioners.

The Mountain Arts District has completed another year dedicated to furthering the development of this region as an arts destination. The Mountain Arts District does this by maintaining an online artist and venue directory and calendar, providing workshops for artists, and promoting public art.

Through its social media presence, the Mountain Arts District is building an infrastructure needed to promote local artists and art venues. All types of artists, be they painters, potters, musicians, performing artists are welcome to subscribe to this service. By having a central location by which tourists and locals can find artists, venues and the vendors that sell local art, the Mountain Arts District is enhancing the arts economy and supporting local businesses. Please see the enclosed screenshots of two artist pages and a page of a local business that benefits from the website.

The Mountain Arts District volunteers continue to market the website in various ways including rack cards at all the welcome centers on the interstate highways, at CVBs, all hotels, resorts in Tucker and Pocahontas counties. At Snowshoe, we have a video clip on Snowshoe TV and their staff is putting our rack cards in welcome packets on selected weekends. We also market the website with our Facebook page, which has an average "total post reach" of over 9,000 a month. On Facebook we promote all art events, public art ideas, resources for artists, etc.

In collaboration with the Art Center, Art Teachers in the School System, ArtsBank, Elkins Parks and Recreation, MAD coordinated the student public art in Elkins City Park. (see enclosed picture and report.) This project was funded by the Snowshoe Foundation.

Mountain Arts District volunteers also organized a workshop called "Photographing Your Art" which was funded by the Tucker County Cultural District Authority. Seventeen participants gained practical experience from a professional photographer on how to take photos that they can use in brochures and on websites. The final report for this project is in the packet.

Mountain Arts District is currently working with artists in five counties. Since it is based in Randolph County, the majority of artists and venues are here. Besides individual subscribers, there are eight venues that represent artists too numerous to count. They include the Art Center, Augusta, D&E Arts and Entertainment, Artists at Work. In addition, the Mountain Music Trail and ArtSpring share links. The area is also promoted with links to the various CVBs.

Challenge:

Succeeding in all these various ways to promote Randolph and the surrounding counties' artists and venues takes an extreme amount of volunteer time. Over the past year and currently we support an AmeriCorps member to help us with the website, marketing and logistical support for projects. MAD's plan is to gradually sustain the work, especially the website through subscriptions from artists, venues and sponsors. It is difficult for artists to pay even the affordable requested price, so we need to seek funding elsewhere.

MAD volunteers are doing all of this work on a budget of \$10,500, with additional in-kind being provided by the board members themselves. Through subscriptions to the website and sponsors MAD is able to raise \$7500. In order to meet basic marketing costs and outreach expenses, we need an additional \$3000.

Anything the Commission can contribute toward this shortfall will be greatly appreciated.
