### ITEMS FOR DISCUSSION/ACTION:

INFORMATIONAL PRESENTATION FROM FRANK CUDA FOR MOUNTAIN ARTS DISTRICT

Pat Schoonover and Frank Cuda appeared before the Commission. There were several other people in attendance from Mountain Arts District also. Pat Schoonover told the Commission their mission is to promote Arts as an economic driver. She said they are trying to pull together arts in the region, but it is difficult to do. She said they have been getting individuals from Tucker, Barbour and Upshur Counties. She said they truly believe this could be an Arts Community. She said we have a destination here in Randolph County and approximately 40,000 people come here to ride the train, etc. She said they have a website that is an online showcase for artists and they hired a professional to set it up. Mr. Frank Cuda said the Mountain Arts District basically functions as a marketing agent for the County. He said they have 1,000 to 3,000 views on their website each week. He said yesterday they dedicated four more 4x5 foot pieces of Artwork at Glendale Park. He said the Childrens' Art in Mill Creek was dedicated also yesterday at George Ward School. This is Art that is made by the children from the Mill Creek area. He said Snowshoe funded them again this year and they are going to put one Art piece in Coalton and one in Harman with that funding. He said the Children's Art

Trail will fit together so that people can put information into their GPS and go find the Art pieces and look at them. He said they are hoping the pieces will last 5-10 years. Commissioner Scott thanked them for coming and said they will consider their request for funding after the first of the year.

## CONSIDER APPROVAL OF EARLY VOTING IN MILL CREEK

Commissioner Scott said the Commission is considering an Early Voting location in Mill Creek for the upcoming 2020 election. County Clerk, Brenda Wiseman said that one of the requirements is for a legal ad to run in the newspaper for 30 days. She said she has spoken to Sharon Mallow from the Russell Memorial Public Library and the board has agreed to let them use that facility for Early Voting. Commissioner See moved to approve submitting a legal advertisement to the newspaper for Early Voting in Mill Creek.

# CONSIDER APPROVAL OF DONATION TO MOUNTAIN STATE FOREST FESTIVAL

Commissioner Scott said Breanna George, Executive Director of the Mountain State Forest Festival, came to the last County Commission meeting and asked for funding for a special building project. He said this is for the Mountain State Forest Festival office building to be better climate controlled to house the gowns, pageantry costumes, photographs, printed media and other historical artifacts. This is all located in the upstairs of the Forest Festival building. Commissioner See moved to approve \$5,000.00 to be taken out of Hotel/Motel Tax funds for the Mountain State Forest Festival special building project.

## CONSIDER APPROVAL OF FUNDING FOR RANDOLPH COUNTY HISTORICAL SOCIETY

Donald Teter, President of the Randolph County Historical Society, appeared before the Commission. He said the Randolph County Historical Society has been in existence since 1924 and right now they are working on improvements to the museum in Beverly. He said they accomplished getting a heating and cooling system in 2017 with the help from the Commission with a grant match. He said now they need to fix the roof of the

building. He said they have obtained a grant from the West Virginia Department of Arts, Culture and History for replacement of the historic metal roof. The roof is over 100 years old and has now reached the end of its useful life and is leaking. He said they will need to raise at least \$12,500.00 in order to match the grant. He said the total cost of the project is \$22,500.00 and this will be for a new metal roof. Commissioner Kesling moved to approve \$5,000.00 out of Hotel/Motel Tax funds to the Randolph County Historical Society for the roof replacement project.
