Meeting was called to order by President Kesling

### PUBLIC COMMENT:

Richard Debias appeared before the Commission. He said he was there to talk about the dash cams again. He would like to get it on the Agenda under items for discussion. He said when he was arrested the officer was so unprofessional and lied about stuff. Mr. Debias said his record is ruined. He said there is no justice in this County. He wants the officers to have dash cams. He said other counties have them and used the Cares Act funds to get them. He said the people in charge in this town shouldn't be in charge.

Julia Elbon appeared before the Commission. She said she was there in response to the 8 rivers presentation that she thought they were going to do today. She said it is regarding the proposed NIOSH Safety and Health laboratory. She said it is not a mine. She said all the issues regarding the water pollution, etc. have all been resolved and debunked. She said the people running this laboratory makes all the rules and regulations so they know what they are doing. She said after looking for 6 years all over our Country, and other foreign Countries, they chose this sight. She said the only thing that will be able to be seen will be the office building. She said there will be 4 years of employment for some people in our area and after that it will be 12-14 permanent employees. She said they will also be doing firefighter training at the site.

Commissioner Scott said he has been speaking to several people about this project and even did a TV station interview. He said the Commission is waiting on the final report to review before they make any decisions regarding this.

# **REPORTS:**

Randolph County Assessor, Phyllis Yokum said all but one employee has returned to work after being on quarantine from the COVID-19 virus. She said they are getting ready to send out 650 increase in tax notices next week.

Randolph County Prosecuting Attorney, Michael Parker said his office is at half staff with people out on quarantine.

Sheriff Rob Elbon said he is having the same issue. He said one deputy tested positive and now more deputies are out on quarantine. He said he wanted to do a new schedule with 24 hour shifts but he is not able to do that now because of this. He said he is dealing with it and everything is going fairly smooth. He said he found out that the Task Force memorandum of understanding was out of date and there needs to be some adjustments made to it, so they are just extending the old one for 90 days until they can work on it. He said he would also like to find some county space for the task force office. He said they are paying \$1,000.00 month rent where they are now.

Randolph County Clerk, Brenda Wiseman said she has one employee off on quarantine because her husband tested positive.

CONSIDER HIRE OF NEW ATTORNEY IN PROSECUTING ATTORNEY'S OFFICE (See copy attached)

Randolph County Prosecuting Attorney, Michael Parker appeared before the Commission. He said his office has a vacancy for an Assistant Prosecuting Attorney due to April Mallow being elected as the Pendleton County Prosecuting Attorney. He said he advertised online for the position and received several resumes. He said after reviewing the resumes and the qualifications of each one, he has chosen Colin Henning. He would like Mr. Henning to begin working on January 11, 2021 with a starting salary of \$60,000.00 per year along with full time benefits. He will be placed on 90 days probationary period. Mr. Parker said a background check was done which came back fine. Commissioner Kesling moved to approve the hiring of Colin Henning as an Assistant Prosecuting Attorney in the Randolph County Prosecuting Attorney's Office with an effective date of hire of January 11, 2021 and with a starting salary of \$60,000.00 per year will full county benefits and he will be placed on a 90 day probationary period. Commissioner Scott said this is something the Commission needs to do for Federal grant purposes. He said they need a letter from the Commission that there are no zoning regulations outside of city municipalities. Commissioner

# CONSIDER PURCHASE OF DISINFECTANT SPRAYER

Commissioner Scott said we have had several instances of COVID positive tests in the offices. He said the Commission has been having to hire someone to come in and spray the offices down and it is very expensive. He said the Commission contacted Wendlings and received a quote for a sprayer and germicide. He said the cost is \$1,540.14. He said the maintenance personnel will be able to use it in the offices as they have been observing the others when they spray. Commissioner Kesling moved to approve the purchase of the disinfectant sprayer and germicide from Wendlings at a cost of \$1,540.14. All yes — Motion passed unanimously

# FIDUCIARY COMMISIONER'S DECEMBER 2020 REPORT ON DELINQUENT FILINGS

# The Estate of Dorothy Rose Montoney (DoD August 14, 2015)

- a. Delinquent documents:
  - i. Final Settlement or Waiver of Final Settlement

Peggy Neale, decedent's sister, was appointed her Executrix. Ms. Neale apparently handled the estate, made distribution and produced a partially executed waiver of final settlement to the prior fiduciary commissioner. However, Rockwood Montoney, II did not sign the Waiver of Final Settlement. Rather, it was signed by Rockwood Montoney, III as "power of attorney" for Rockwood Montoney, II. The issue is that Rockwood II was deceased at the time Rockwood III signed the document. A power of attorney does not confer any legal rights upon the agent after the principal's death.

Rockwood Montoney, III is a resident of Texas. The undersigned attempted to contact Rockwood Montoney, III in May of 2020. His wife, Zoe Montoney, indicated she would give Rockwood, III a message to return the call. He did not. I tried to contact him again on December 22, 2020, to no avail. The Executrix, Peggy Neale, died February 2, 2019.

W.Va. Code §44-4-2 & 3 require annual accountings by the personal representative, or accountings every three years in the case of small estate. The Executrix of the above named estate has failed to file an accounting since the estate's inception in 2015.

W.Va. Code §44-2-1(b) requires the personal representative file a waiver of final settlement or report of receipts and disbursements "within a reasonable time after the date of recordation of the appraisement." The Executrix of the above named estate has to make the appropriate filings within a reasonable time.

W.Va. Code §44-4-14A(a)-(e) requires the personal representative to close the estate within five years. The Executrix of the above named estate has failed to do so and in fact there is no current personal representative who can close the estate.

No continuance has been requested or granted.

Accordingly, the undersigned is of the opinion that the County Commission should direct Rockwood Montoney, III to file a statement to show cause why the county commission should,

a. not appoint the Sheriff of Randolph County as Administrator, administratively close the estate, or take such other action as may be proper.
