Meeting called to order by Commissioner Scott

#### PUBLIC COMMENT:

Bob Jones appeared before the Commission. He said he wanted to give the Commission a Freedom of Information Act request but could not find the form on their website. He said he printed one off from the City of Elkins website. He presented it to the Commission. He said they might want to put one on their website.

Phil Hudok appeared before the Commission. He said he wanted to talk about issues he thinks are important. He showed the Commission a printout he got from a pharmacy regarding the COVID-19 vaccine and it is blank. He said it is an experimental drug and he is not sure what is going to happen. He said more deaths have been reported this year since COVID-19 than in previous 28 years. He played a clip from President Biden urging people to get the vaccine but Mr. Hudok doesn't agree with it. He gave each Commissioner a DVD that has a man that worked for the CDC on it giving information. He said there is no one more knowledgeable than that man. He said there is no risk for people under 18. He said the tests are not accurate. He said 13 years ago the Helvetia Clinic committed fraud by having people write down the swine flu when it wasn't that, he said he should have done something then. He said he has brought questions and serious concerns to the Commission and wants to know what have they done? He said where do we go from here?

### MINUTES:

### REPORTS:

911/OEM Director Cindy Hart reported that they have had a peak of people coming in to get new 911 addresses. She said people who have P.O. boxes didn't get a letter and are just now coming in for those new physical addresses. She said there was an emergency on Sunday with HealthNet running out of fuel and they got it within 6 minutes. She said Huttonsville PSD had a malfunction with their water lines and Webster County was going to lend them a water buffalo and stage it a Beverly but it was repaired so they didn't need it. She said it's been a busy week.
