PUBLIC COMMENT:

Richard DeBias appeared before the Commission. He gave a copy of his public comment to the Commission. (See attached copy) Mr. DeBias read his public comment out loud.

MINUTES:

Commissioner See moved to approve the minutes from the regular meeting that was held on December 2, 2021, as submitted. All yes – Motion passed unanimously

REPORTS: Curt Gainer from Randolph County EMS reported that an ambulance struck a deer Tuesday night and messed up the bumper but the ambulance is still in service. He said they have 3 paramedic students getting ready to test and hopefully they pass so there will be more medics in the County.

Sheriff Elbon reported that there was recently a test given for entry level Deputy. He said 11 applied but only 6 showed up for the physical agility in which 4 passed and then took the written test. He said they are waiting for the test results to come back now.

Commissioner Kesling announced that the next meeting of the County Commission will be on January 6, 2022 at 1:30 p.m.

ITEMS FOR DISCUSSION/ACTION:

INFORMATIONAL PRESENTATION AND FUNDING REQUEST FROM MOUNTAIN ARTS DISTRICT

Pat Schoonover appeared before the Commission on behalf of the Mountain Arts District. She thanked the Commission for their past contributions. She said the Mountain Arts District continues to support a website for local artists to showcase their art. She said this website is kept up by another person in the Community. She said their Facebook page has been very positive too. She also discussed the young artist art trail and the various projects of art throughout the County. She said they are getting ready to put art at Harman and Beverly schools. She said they are having art contests for young kids and high school kids. She said it is a very positive thing and they get money and prizes for it. She said they try to help other Counties in their region too. She said she hopes the County Commission can continue to support the Mountain Arts District. Commissioner Siler moved to approve \$2,000.00 to the Mountain Arts District and that is to be taken out of Hotel/Motel Tax funds. All yes — Motion passed unanimously

REPORTS:

Erin Golden, Director of North Central Community Corrections appeared before the Commission. She reported that there are currently 101 participants on the program and the program has saved the County \$751,928.00 in regional jail bills so far this fiscal year.

CONSIDER SIGNING RESOLUTION FOR LAUREL MOUNTAIN WIND (See attached copy)

Chris Callis from Jackson and Kelly in Charleston appeared before the Commission. He said this Resolution is for Stantec Consulting Services, Inc. to do an evaluation of decommissioning of the AES Laurel Mountain, LLC Windmills. He said the windmills are located in Randolph and Barbour Counties. He said this is a proposal for a new contractor to do a study on how much it would cost to decommission the windmills. He said this study will determine salvage value and if it is worth taking them down or not. He said there really needs to be a formal agreement done about decommissioning the windmills but they do not have that now. He requested that the County Commission get someone to get that agreement worked out. Commissioner See moved to approve the signing of the Resolution for AES Laurel Mountain Wind, as submitted. All yes – Motion passed unanimously

APPROVAL OF DESIGN DEVELOPMENT DRAWINGS, PROJECT MANUAL AND MEMO FOR POOL/SPLASH PAD PROJECT AND CONCESSION STAND

Commissioner Kesling said the Commission met with engineers E.L. Robinson and have the final drawing of pool/splash pad here today for public viewing. He said if the Commission approves it today that will give them the go ahead to put it out for bids in the spring and hopefully construction can begin in the spring. Stanley Teets from Elks Lodge was also present. Commissioner Siler moved to approve the design development drawings, project manual and memo for the pool/splash pad project and concession stand, as presented. All yes – Motion passed unanimously

CONSIDER APPROVAL OF FUNDING REQUEST FROM MIDLAND PSD

Ron Vance, Manager of Midland Public Service District, appeared before the Commission. He said they are working on a waterline extension project to go into the Bowden area. He said the total cost of this project is 3.75 million dollars. He said they have several avenues for funding but need all they can get. He said this will be a potential of about 100 customers being added. Commissioner Kesling said the Commission has been reviewing the ARP funding that they received this year and will also get more next year. He said projects such as this is what they are focusing on right now. Commissioner See moved to approve \$500,000.00 for Midland Public Service District for their waterline extension project and that is to be taken out of ARP funds. All yes – Motion passed unanimously

CONSIDER APPROVAL OF FUNDING REQUEST FROM RUSSELL MEMORIAL PUBLIC LIBRARY

Commissioner Kesling said the libraries are already given funding in the County budget so there does not need to be a vote on this.

CONSIDER HIRING OF OEM/911 DIRECTOR

Commissioner Kesling said 10 people applied for this position and the Commission conducted 5 interviews. He said each person was asked the same set of questions during the interview. He said the Commission has chosen Shonna Fox as the new OEM/911 Director for Randolph County. He said she has prior experience in Barbour County. Commissioner Siler moved to approve the hiring of Shonna Fox as OEM/911 Director with a starting salary of \$60,000.00 per year will full benefits and her effective date of hire will be December 20, 2021. All yes — Motion passed unanimously

CONSIDER HIRE OF TAX DEPUTY

Sheriff Elbon appeared before the Commission. He said he had an opening in his office for a tax deputy and has chosen Jennifer J. Roberts for the position. He said this would be a full time position with county benefits and her starting salary would be \$22,000.00 per year and her starting date would be December 20, 2021 and she will be placed on a 90 day probationary period. Commissioner See moved to approve the hiring of Jennifer J. Roberts, as presented. All yes—Motion passed unanimously

CONSIDER HIRE OF 4H DIRECTOR

Commissioner See moved to table this item. All yes - Motion passed unanimously

CONSIDER APPROVAL OF CHANGES TO COUNTY HOLIDAY LIST FOR CHRISTMAS EVE AND NEW YEAR'S

Commissioner Kesling said in following with the Governor's proclamation the courthouse will operate on a half day holiday schedule on Thursday December 23, 2021 and Thursday December 30, 2021. He said Friday December 24, 2021 and Friday December 31, 2021 will remain as full day holidays as previously scheduled. Commissioner Siler moved to approve the changes in holidays, as presented. All yes — Motion passed unanimously

CONSIDER APPROVAL TO SELL COUNTY PROPERTY AT PUBLIC AUCTION

Commissioner Kesling said the enforcement committee cleaned up a piece of property in Highland Park and the landowner turned the property over to the County. He said they want to sell that property at public auction and Sheriff Eibon would be the one to do that after it has been advertised. Commissioner Siler moved to approve selling of the property at Highland Park at a public auction. All yes – Motion passed unanimously

CONSIDER APPROVAL OF PURCHASE OF REPLACEMENT CRUISER FOR K9 OFFICER

Sheriff Elbon said that Deputy Knotts cruiser is a total loss and this is the cruiser that was equipped with special equipment for the K9 Officer, Hacker. He said the insurance money will pay for a new cruiser at it would be no cost to the County. He said the special equipment will be taken out of the wrecked cruiser and installed into the new one. Commissioner See moved to approve the purchase of a replacement cruiser, as presented. All yes — Motion passed unanimously

CONSIDER APPROVAL OF REVISED QUOTE FROM CASTO TECHNICAL

Commissioner Kesling said Casto Technical is the ones doing the new heating and air conditioning system in the main courthouse. He said since they did the quote the prices have went up by \$18,360.00. He said the Commission needs to approve the amended quote so they can proceed. Commissioner Siler moved to approve the amended quote with an increase of \$18,360.00 for Casto Technical and that is to be paid out of ARP funds. All yes — Motion passed unanimously

CONSIDER APPROVAL OF QUOTE FOR PURCHASE OF RADARS

Sheriff Elbon said they lost 2 radars recently and those were refurbished ones. He said he has priced the radars and can get 4 for \$9,320.00 and these are new ones, not rebuilt ones. Commissioner See moved to approve \$9,320.00 out of courthouse contractual funds for 4 new radars for the County deputies. All yes – Motion passed unanimously

CONSIDER APPROVAL OF PAYMENT FOR WV CFIA 18TH CYCLE GRANT

Commissioner Kesling said this is the second payment on the sidewalk project. The amount of this payment would be \$23,776.17. Commissioner See moved to approve the payment of \$23,776.17 and that is to be paid out of the courthouse facilities improvement line. All yes — Motion passed unanimously



Dear Commissioners,

On behalf of Mountain Arts District, I have requested to be on the agenda for Thursday's December 16,2021 meeting to ask for support for this organization which is committed to enhancing the role of the arts as an economic driver for the north-central region.

Last year you gave us some funds for public art and administration of our Artist/Venue directory and arts calendar. With that funding we were able to extend the Youth Art Trail, formerly known as the Children's Art Trail, to Harman and Beverly Schools. Three pieces of children's art will be dedicated at Harman School in December, 2021 and the Beverly Art will be completed in early 2022. Attached are the pictures of the three pieces for Harman School. Our work has inspired the communities of Belington and Buckhannon which are planning their own projects. This small attempt to create a more artistic environment is becoming a regional Youth Art Trail. The GPS coordinates are on the MAD website.

MAD continues to build a marketing infrastructure of an online showcase for artists and venues as well as an arts event calendar. The website became fully operational in September of 2016. It is not enough to get artists and venues signed up on a website, but you have to bring tourists and residents to the website and to social media so that they can meet the artists, find out where to purchase their art, and participate in art events. Through the use of social media, rack cards and other marketing efforts, MAD plans to help artists grow their businesses while adding value to the effort of making Randolph County and the region an arts destination. The Facebook page has over 1,595 followers and has on average 2000 hits per week. The website gets about 1000 hits per month.

Randolph County Subscribers

In Randolph County, there are nearly 30 subscribers to the website, including individuals as well as co-ops, art-related businesses and performing venues that feature hundreds of artists. For

example, we have the Art Center, Artists at Work, the Weavers Guild, and (Augusta) whose subscriptions benefit large numbers of artists and local residents as well. We have exchanged links with Elkins Tourism and other CVBs, ArtSpring and the Mountain Music Trail which represents over 40 artists and venues. Growing the list of artists and venues takes a good deal of time and effort, making our mission more challenging as all the 'on-the-ground' work is done by volunteers.

Focusing on developing tourism and art based economic development, you could say the Mountain Arts District is functioning as a subset of a CVB.

Funding Request:

MAD is requesting a total of \$2,000 for two purposes: the Youth Art Trail and strengthening the arts economy by putting our marketing activities in professional hands:

Youth Art Trail

MAD is planning to increase children's public art in Randolph County, and promote the Youth Art Trail by designing and distributing print and digital engagement specifically for this purpose. The Art Trail will be an attraction for Randolph County, and add to the creative environment needed to be considered an arts destination. Grants from the Snowshoe Foundation have supported our Youth Art Trail in Randolph County.

Professional Digital Marketing Consultants Marketing Needs

In order to give better and consistent service to artist entrepreneurs, and promotion of art events in Randolph and the region, MAD hired LMC and Associates to take over the postings to the Facebook page and Ajuga, Inc to update and improve the website information. They are currently hired on a month- to- month basis as a pilot and already we have seen increases to our FB page and visits to our artist pages on our website.

Also, the monies received from the RCC allowed us to contract The Art Medium Company to produce the children's large artwork to be displayed in Randolph County. The financial support from the Randolph County Commission has also allowed us to support local businesses to support our mission and county projects.

RESOLUTION OF APPROVAL OF STANTEC CONSULTING SERVICES INC. FOR EVALUATION OF DECOMMISSIONING OF THE AES LAUREL MOUNTAIN, LLC WIND POWER PROJECT

WHEREAS, the West Virginia Public Service Commission (PSC) on November 20, 2008 entered an order in Case 08-0109 granting to AES Laurel Mountain, LLC the right to construct 65 wind turbines on Laurel Mountain, located in Randolph and Barbour Counties West Virginia.

WHEREAS, the above referenced order sets forth as a preconstruction condition (Section V. Preconstruction Condition #10. at page 70) a requirement that AES Laurel Mountain, LLC obtain a report from a qualified independent third party at intervals of not more than five years to determine the amount, if any, necessary to provide for decommissioning of the facility.

WHEREAS, a further requirement of the above referenced condition is that AES Laurel Mountain, LLC obtain the approval of the Randolph County Commission regarding selection of the independent third party expert.

WHEREAS, in connection with an update of the existing decommissioning study to be conducted in 2022, AES Laurel Mountain, LLC has identified Stantec Consulting Services Inc. ("Stantec") as the independent third party to perform the updated study and asserts that the firm is a leading expert in the wind energy industry and routinely acts in the capacity of an independent third party engineer for purposes such as this evaluation for local governments and lenders.

WHEREAS, AES Laurel Mountain, LLC has provided the Randolph County Commission with sufficient information regarding the qualifications of Stantec and the County Commission has reviewed and considered this and any other available information regarding the selected firm.

MEMO TO ALL EMPLOYEES

December 16, 2021

To whom it may concern:

Last year, Congress passed the Families First Coronavirus Response Act, which mandated that employees be granted up to 80 hours of paid leave in the event they were affected by COVID-19.

Those provisions expired December 31, 2020. In 2021, Randolph County employees were granted up to 80 hours of paid COVID-19 related sick leave.

Beginning January 1-2022, Randolph County employees will be granted 80 hours of paid COVID-19 related sick leave; this policy will remain in place until July 1, 2022, when the policy will be reevaluated.

This leave will not be counted against an employee's annual or sick leave. If the courthouse facilities must be closed and staff is unable to report to work, this time will not be counted as leave even if the 80 hours have been used already. If a department head is required split their office into split shifts, this time will not be counted as leave even if the 80 hours have been used already.

This policy will remain in effect unless otherwise mandated by state or federal statute.
