MINUTES:

Commissioner Kesling moved to approve the minutes from the regular meeting that was held on June 14, 2022, as submitted. All yes – Motion passed unanimously

Commissioner Kesling moved to approve the minutes from the special meeting that was held on June 22, 2022 with an amendment of the bid amount for the pool/splash pad to \$2,163,000.00 instead of 2.1 million dollars. All yes — Motion passed unanimously

REPORTS:

Sheriff Elbon reported that his department has one vehicle down at this time. He said he thinks it is a timing chain issue and the vehicle has 97,000 miles on it.

ANNOUNCEMENTS:

Commissioner See announced that the next regular meeting will be held on July 21, 2022 at 1:30 p.m.

Commissioner Kesling announced that there will be a ground breaking ceremony at the pool tomorrow morning at 10:00 a.m.

Commissioner See announced that there is a box in the courthouse annex lobby for personal care items for students and this is being done by the United Way.

ITEMS FOR DISCUSSION/ ACTION:

CONSIDER APPROVAL OF NEW HIRE FOR 911 CENTER

Robert Daman appeared before the Commission. He said they would like to move Bradley Workman from part time status to full time status at the 911 Center. He said they would like this to be effective from July 4, 2022 and he will receive the same pay but will now be able to get the County benefits. His salary is already covered in the budget. Commissioner Kesling moved to approve this request, as presented. All yes – Motion passed unanimously

Mr. Daman said they would also like to re-hire Eric Swecker back as a Telecommunicator Trainee full time with benefits. This would be effective July 8, 2022 with a starting pay of \$12.25 per hour and he will be placed on a 6 month probation period and this is covered in the current budget. Commissioner Kesling moved to approve this request, as presented. All yes – Motion passed unanimously

CONSIDER APPROVAL OF QUOTE FROM DIGITAL SOUP

Commissioner Kesling said this is a quote from Digital Soup for camera work behind the Wees Annex. The quote is in the amount of \$986.00. Commissioner Kesling moved to approve the quote from Digital Soup in the amount of \$986.00 and that is to be taken out of other buildings equipment line. All yes – Motion passed unanimously

CONSIDERATION OF AMENDED COVID LEAVE POLICY

Commissioner Kesling said the Commission extended the 80 hours of paid COVID leave until July 1st. He said now since things have settled down some and the quarantine time has changed they would like to amend that policy to 40 hours of paid COVID leave until December 2022. He said they will re-evaluate it after that. He said this time off will not be counted against employees sick or annual leave, but they must have a doctor's slip to use COVID leave. Commissioner Kesling moved to approve the amended COVID leave policy as discussed. All yes—Motion passed unanimously

CONSIDER APPROVAL OF CLAYTOR ENTERPRISES, LLC TO PREPARE ANNUAL FINANCIAL STATEMENT FOR FISCAL YEAR ENDING JUNE 30, 2022 (See copy attached)

County Clerk, Brenda Wiseman presented a proposal from Claytor Enterprises, LLC to the Commission. She said Mr. Fred Hess that has been doing the financial statement for the last couple of years sent an email that said he couldn't do it this time. Ms. Claytor has done the financial statement for Randolph County in the past and did a good job. She was unable to do it for a while as she was running for office and was too busy. The fee for her services is \$5,000.00. Commissioner Kesling moved to approve Claytor Enterprises, LLC to prepare the annual financial statement for fiscal year ending June 30, 2022, as submitted. All yes – Motion passed unanimously

CONSIDER APPROVAL OF FIDUCIARY COMMISSIONER'S RECOMMENDATION ON THE ESTATE OF DORIS JEAN POLING (See copy attached)

County Clerk, Brenda Wiseman presented the recommendation to the Commission. She said Jennifer Morgan was appointed as Fiduciary Commissioner to hold a hearing on this estate regarding a claim that was submitted regarding a tractor. The Commissioners read and reviewed the recommendation. Commissioner Siler moved to approve the recommendation of the Fiduciary Commissioner on the estate of Doris Jean Poling, as submitted. All yes — Motion passed unanimously

CONSIDER APPROVAL OF INCREASED MILEAGE REIMBURSEMENT RATE

Commissioner Kesling said the Commission usually goes along with the standard mileage rate set by the State. He said that rate has went up to 62.5 cents per mile so they need to approve that increase today. Sheriff Elbon said they have had vehicles ordered since last February through Ford. They still have not received them and there is no date when they will be coming. He said they are not even responding to his emails anymore. He said he started looking elsewhere and has found 3 vehicles that will work for them. He said one is for the task force and two will be used as patrol cruisers. He said the two cruisers are white so they will need to be wrapped in black and the one for the task force will need a bed cover. Commissioner Kesling said they previously budgeted \$200,000.00 for the new vehicles. Commissioner Kesling moved to approve the request for the three new vehicles in the amount of \$121,548.58 and that is to be taken out of the Courthouse Equipment line. All yes – Motion passed unanimously

Commissioner Kesling moved to approve a quote in the amount of \$8,000.00 to wrap the two white cruisers in black and that is to be taken out of the Courthouse Equipment line. All yes – Motion passed unanimously

Re: Estate of Doris Jean Poling

Dear Clerk Wiseman,

On March 30, 2022, Frank D. Edmond filed a claim against the Estate of Doris Jean Poling. By letter dated May 3, 2022, I set the matter for hearing on June 8, 2022, at my office. Below is my report of said hearing and recommendation to the Randolph County Commission in regard to the issues raised at said hearing.

Present at said hearing were Executrix, Rebecca A. Surface and her attorney, R. Mike Mullens; Petitioner, Frank D. Edmond and his attorney, Daya M. Wright. Both Counsels prepared statements and called witnesses. Petitioner called the following to testify: Karry Nagle, Valda Nagle, Frank D. Edmond, Frank Edmond, Jr., Virginia Newsome, Craig Newsom and Virginia Pudder. Executrix called Jefferson Triplett, Rebecca Surface, Marshall Coontz and Wesley Elmore.

Primary complaint of Petitioner is the disposition of a Kubota tractor pursuant to the Last Will and Testament of Doris Jean Poling in the Third Section of said Will, to Dave Abel. Petitioner contends that the deceased, Doris Jean Poling, gifted said tractor to himself prior to her death and therefore, the tractor was not available for distribution to Mr. Abel.

Executrix counters that the tractor was never given to Petitioner but loaned to Petitioner and should be returned to Executrix to be distributed pursuant to the Last Will and Testament of Doris Jean Poling.

** Approved by the Randolph County Commission on July 7, 2022**

From the testimony presented by Petitioner, the following information was submitted:

- 1. In March of 2020, Frank Edmond hosted a birthday party for himself. Present at this party were Frank Edmond, Karry Nagle, Valda M. Nagle, F Frank Edmond, Jr., Virginia Newsome, Craig Newsom, Virginia Pudder and the deceased, Doris Jean Poling.
- 2. At said party, witnesses testified that they overheard the deceased, Doris Jean Poling, say that the tractor was a gift to Frank Edmond for his help to her and for his birthday.
 - 3. Frank D. Edmond is a nephew of Doris Jean Poling.
 - 4. Frank D. Edmond had possession of said tractor since 2021.
- 5. Frank D. Edmond visited deceased four to five times a week and used the tractor to do chores at deceased's house and at his house.
 - 6. Frank D. Edmond at all times considered the tractor his following his birthday party in 2020.
 - 7. There is no paperwork transferring the tractor from deceased to Petitioner.
- 8. Following the birthday party, witnesses testified that on separate occasions following the birthday party they overheard the deceased refer to the tractor as Petitioner's.

From the testimony presented by the Executrix, the following information was submitted:

- 1. Executrix is the deceased's niece.
- 2. Executrix and Petitioner are not brother and sister.
- 3. Last Will and Testament was prepared by Jefferson Triplett after conversations with Rebecca Surface in late November 2021. Doris Jean Poling was in intensive care at Davis Medical Center suffering from COVID-19. Doctor Chua certified that Mrs. Poling was of sound mind and competent to make and sign a Will. Mr. Triplett met with Mrs. Poling at the hospital, reviewed the Will he had prepared from the notes presented to him by Mrs. Surface, and witnessed Mrs. Poling sign said Will. Other than reviewing the disbursement of assets, there was no discussion of the tractor or the tractor's ownership. Mrs. Poling signed her Last Will and Testament, in ICU at Davis Medical Center on December 14, 2021, and subsequently died the next day.
- 4. Mrs. Surface testified that it was Mrs. Poling's wish that Dave Abel have possession of the tractor since Mr. Abel would need the tractor to take care of the real estate he was inheriting. Mrs. Surface also testified that there was no mention of a gift of the tractor to Petitioner.
 - 5. Mrs. Surface had no knowledge that the tractor was presently stored at Petitioner's house.
- 6. Marshall Coontz and Wesley Elmore testified that neither knew of any gift of the tractor to Petitioner from deceased. Both understood that the tractor was at Petitioner's house for use to mow Petitioner's lawn and for use at Petitioner's house. Both testified that Mrs. Poling intended to fix up a shed at her house to house the tractor once it was returned.

Kubota Tractor

Under Section THIRD a(iii) of the Last Will and Testament of Doris Jean Poling, the testator specifically devises her Kubota tractor to her nephew, Dave Abel. Furthermore, at no point during her conversations with Mrs. Surface or Mr. Triplett, did Mrs. Poling bring up the ownership of her Kubota tractor or a gift of it to Frank D. Edmond. There is no evidence of any document or other writing transferring the ownership from Mrs. Poling to Mr. Edmond.

However, Petitioner presented multiple witnesses who overheard the deceased gifting the Kubota tractor to Petitioner at a birthday party in 2020. Furthermore, five of those witnesses overheard Mrs. Poling state on other separate occasions that the Kubota tractor belonged to Petitioner. Petitioner moved the Kubota tractor to his property sometime in 2021 and from the date of the 2020 birthday party, acted as though the tractor belonged to him.

A Kubota tractor does not have a title similar to that of a vehicle which could be presented to change ownership. Absent any written agreement, there would not be any other written documentation to transfer ownership of the tractor.

A specific legacy is a gift of a particular specified thing, or of the proceeds of the sale of such thing, or of a specified fund, or of a designated portion of such fund [Cuppett v. Neilly, 143 W. Va. 845 (1958)]. A specific legacy cannot be satisfied except by the identical thing bequeathed. If that identical thing is not in existence, or has been disposed of, so that it does not form a part of the testator's estate at the time of his death, the legacy is extinguished and the legatee's rights are gone. The technical term for this is "ademption". A specific legacy is adeemed if the thing bequeathed was not part of the estate of the testator at the time of his/her death because it was previously sold, exchanged or converted into some other thing.

Trailer:

Testimony was provided that a trailer, not mentioned in the Last Will and Testament, also exists and said trailer was meant to go with the Kubota tractor. The Executrix is requesting that said trailer be given to Mr. Abel since he was devised the Kubota in the Will. Petitioner is contending that it would following the Kubota to him as part of the gift of the tractor. The sole purpose of the trailer is for transporting the tractor.

Appraisement:

Testimony was also provided that all of the specific bequests, including the Kubota tractor, were omitted from the Appraisal of the Estate of Doris Jean Poling. Executrix testified that she was given incorrect advice and left off those items pursuant to that advice.

Recommendations to Randolph County Commission for the Estate of Doris Jean Poling:

It is my recommendation that the following be approved by the Randolph County Commission in regard to the issues raised by that hearing held on June 8, 2022:

- 1. Appraisement. Executrix must amend the appraisement to include all assets of the Estate of Doris Jean Poling. Specifically, all items bequeathed and devised pursuant to Section THIRD must be identified and valued on the Appraisement. This shall be done in a reasonable timeframe and pursuant to the recommendations below.
- 2. <u>Kubota tractor</u>. Although the Last Will and Testament spells out a specific bequest to Dave Abel, said bequest fails by extinction. There is enough supporting evidence to suggest that prior to her death, Doris Jean Poling gifted the Kubota tractor to her nephew. As such, at the time of her death, Doris Jean Poling no longer owned the tractor to devise to anyone else. This ademption by extinction occurs because the property specifically described in the will is not in the estate at the testator's death. When the Appraisement is amended, the Executrix is not to include the tractor as an asset of the deceased.

3. <u>Trailer</u>: Doris Jean Poling's Will does not mention or devise the trailer used to move the Kubota tractor. The title for the trailer is still in her deceased husband's name. Although it can be argued that the trailer should follow the ownership of the tractor, there is no evidence to suggest that this trailer was part of the gift given to Mr. Edmond. Therefore, the trailer shall be returned to the Executrix in a timely manner, listed and valued on the Appraisement and follow disbursement according to Section FOURTH in the Last Will and Testament of Doris Jean Poling, whereby the trailer shall be sold and the proceeds allocated pursuant to Section Fourth (a) and (b).
