Commissioner See moved to approve the minutes from the regular meeting that was held on November 18, 2021, as submitted. All yes – Motion passed unanimously

#### ANNOUNCEMENTS:

Commissioner Kesling announced that the next meeting of the County Commission will be on December 16, 2021 at 1:30 p.m.

#### ITEMS FOR DISCUSSION/ACTION:

CONSIDER APPROVAL OF MOVING AN ASSESSOR'S OFFICE EMPLOYEE FROM PART TIME TO FULL TIME STATUS (See copy attached)

Randolph County Assessor Phyllis Yokum appeared before the Commission. She said a 25 year employee in her office and office deputy, Debbie Isner, is retiring in January. She said she is requesting to move Stephanie Simmons, who is currently a part time employee, to a full time employee. She would like this status change to become effective on December 20, 2021. She said the salary would be \$25,000.00 per year with full county benefits and this amount will be covered by her budget. She said she will also be moving some positions around in her office to cover all aspects of the Assessor's Office. Commissioner See moved to approve the full time hire of Stephanie Simmons in the Assessor's Office with a starting salary of \$25,000.00 with full county benefits and she will begin working full time on December 20, 2021. All yes — Motion passed unanimously

#### CONSIDER HIRE OF NEW DEPUTY IN SHERIFF'S OFFICE (See copy attached)

Lieutenant Bryan Talkington appeared before the Commission. He said they would like to hire Lantz Elbon as a full time benefited uncertified probationary deputy sheriff. He said Sheriff Elbon appointed a hiring board to complete the hiring process. He said the members appointed were himself, Chief Deputy Bradley Sharp and Captain Richard Swisher. He said an extensive background investigation was completed which Mr. Elbon successfully passed. He said the starting salary for an uncertified deputy is \$40,000.00 and after completion of certification would be raised to \$44,000.00. He would like to begin working after submitting a two week notice to his current employer. Commissioner Siler moved to approve the hiring of Lantz Elbon as an uncertified probationary deputy sheriff with a starting salary of \$40,000.00 per year until certified at which time it will be raised to \$44,000.00 per year. He will begin working after giving a two week notice to his current employer. All yes — Motion passed unanimously

#### CONSIDER APPROVAL OF FUNDING REQUEST FROM THE TOWN OF MILL CREEK (See copy attached)

Commissioner Kesling said now that the third Commissioner is in place they have begun working on the ARP (American Rescue Plan) funding. He said the County received 2.7 million dollars this year and will receive 2.7 million dollars next year in ARP funding. He said the State wants them to use that money for infrastructure projects. He said the Town of Mill Creek has requested funding for their water project which they have been working on since 2012. They serve approximately 400 customers and they need to replace all the old water lines. The amount they are asking the Commission for is \$668,021.76. If they can get that then they can get a matching grant in the amount of \$950,000.00. Commissioner See moved to approve the funding request from the Town of Mill Creek in the amount of \$668,021.76 and that is to be taken out of the ARP funds. All yes — Motion passed unanimously

#### CONSIDER APPROVAL OF FUNDING REQUEST FROM HUTTONSVILLE PSD (See attached copy)

Commissioner Kesling said this is another request the Commission received for the ARP funding. He said they already gave them some funding from the ARP funds but they need more to complete their project of replacing water meters, an aerator for the wastewater plant and a new billing system. Commissioner Siler moved to approve the funding request from Huttonsville Public Service District in the amount of \$139,500.00 and this is to be taken out of ARP funds. All yes – Motion passed unanimously

#### CONSIDER APPROVAL OF QUOTE FROM MOUNTAINEER GENERATOR SERVICE

Commissioner Kesling said they have an annual contract for monitoring 17 generators that the County has. He said they need to do a system upgrade at a cost of \$12,375.00. He said the total cost for 2022 is going to be \$35,385.00. Commissioner See moved to approve the quote from Mountaineer Generator Service in the amount of \$35,385.00 and that is to be taken out of courthouse contractual funds. All yes—Motion passed unanimously

CONSIDER APPROVAL OF CHANGES OF THE MAGISTERIAL DISTRICTS AND PRECINCT BOUNDARIES FOR RANDOLPH COUNTY (See attached copy)

Randolph County Clerk Brenda Wiseman appeared before the Commission. She had a map of the new magisterial district and precinct boundary lines for everyone to see. She said every 10 years after the census is done there has to be redistricting done. She said it starts off with the State doing redistricting in Charleston and then once they do their part it comes to the County to do their redistricting. She said due to the House of Delegates line changing and going right through the middle of the County there had to be some changes made at the County level. She said they have not added or taken away any precincts but had to change the boundary lines of a few of the precincts so some voters may have to go to a different polling place than before. She said anyone affected by the change will receive a new voter's card in the mail along with a letter explaining why their polling place was changed. She said this will be done before the start of candidate filing on January 10, 2022. She said an order has to be signed by the Commission today to make these changes effective starting with the May 2022 Primary Election. Commissioner Siler moved to approve the changes in the magisterial districts and precinct boundaries for Randolph County, as submitted. All yes – Motion passed unanimously

Dear County Commissioners,

The Town of Mill Creek is seeking your financial assistance to complete our water project, consisting of replacing all water lines in the system, some of which are over one hundred old. Our system serves approximately 400 customers, residential, commercial and government. We started the design in 2012 and broke ground the spring of 2016, but our contractor walked off the job in July of 2016 leaving the town with a partially completed water system. We spent two and one half years in litigation before settling with the contractor and allowing us to proceed with the project. We bid the project last month and opened bids to find that the project cost had increased more that we anticipated leaving us almost two million dollars short in our funding. The project is being completed in two contracts, the first being the line replacement and the second a new water tank and water plant renovations. The Town has committed \$83,773.68 to completing contract one but we need assistance to finish contract two, with a cost of approximately \$1,900,000. If we can raise \$950,000 we would qualify for an IJDC matching grant for the same amount allowing us to complete the project without another rate increase on our citizens who are already dealing with a series of increases to cover the cost of the original project. Attached you will find two schedules, one showing the draft copy of the preliminary project budget (schedule B) and the other a breakdown of the probable construction cost in draft form. Please be aware that these are preliminary numbers in draft form.

The Town is committed to using our ARPA allocation in full to complete this project. This includes the \$140, 989.12 that we received this month and next years allocation in the same amount, for a total of \$281,978.24. this would leave a shortage of \$668,021.76 that we are respectfully asking the Commission to fund from their ARPA funds.
