## ITEMS FOR DISCUSSION/ACTION:

#### STATE AUDITOR'S OFFICE PRESENTATION

West Virginia State Auditor, J.B. McCuskey, along with staff members Gary W. Cogle, Jr. and Jeff Waybright appeared before the Commission. Auditor McCuskey said the State if working on lowering audit costs and changing audit standards for the counties. They would like to implement a statewide accounting system that all 55 counties could use and this information would be cloud based so that audits could be done from Charleston. This system would be able to do financial reports, payroll etc. He said what he had to present today was the WV Checkbook program. He showed the website to the Commission and said this gives access to all the State's revenue and expenses. He did examples to show the Commission how it works. He said with this system vendors can look and see what other vendors have been paid for similar work and then they know how much to bid on a project which saves the taxpayers money in the long run. He said Monongalia County and Berkeley County have the system now and thirteen more will have it by the end of the year. Auditor McCuskey said this is the 53<sup>rd</sup> County Commission meeting he has attended to present the program. He said he feels the state needs to provide these services. Commissioners asked about the time frame to get the system. Mr. McCuskey said he would suggest they have another meeting and have public comment and vote on it. He said it would probably be three months before they could install it. Commissioners asked about the cost to the County? Mr. McCuskey said for counties that can afford it the cost would be \$3,000 for the first year and \$1,500 every year after. He said some counties cannot afford it and they are providing it to them for free. Commissioners asked if there was a written proposal that they could have to get it put on the agenda for the next meeting? Mr. McCuskey said there was not but he would draft something and get it to them by email.

A representative from Senator Manchin's office entered the meeting. He said he was no longer going to be the regional coordinator for Randolph County and he brought along his replacement to introduce to the Commission.

Adam Flack said he would be the new regional coordinator for Randolph County. He said he will be covering 9 counties total.
